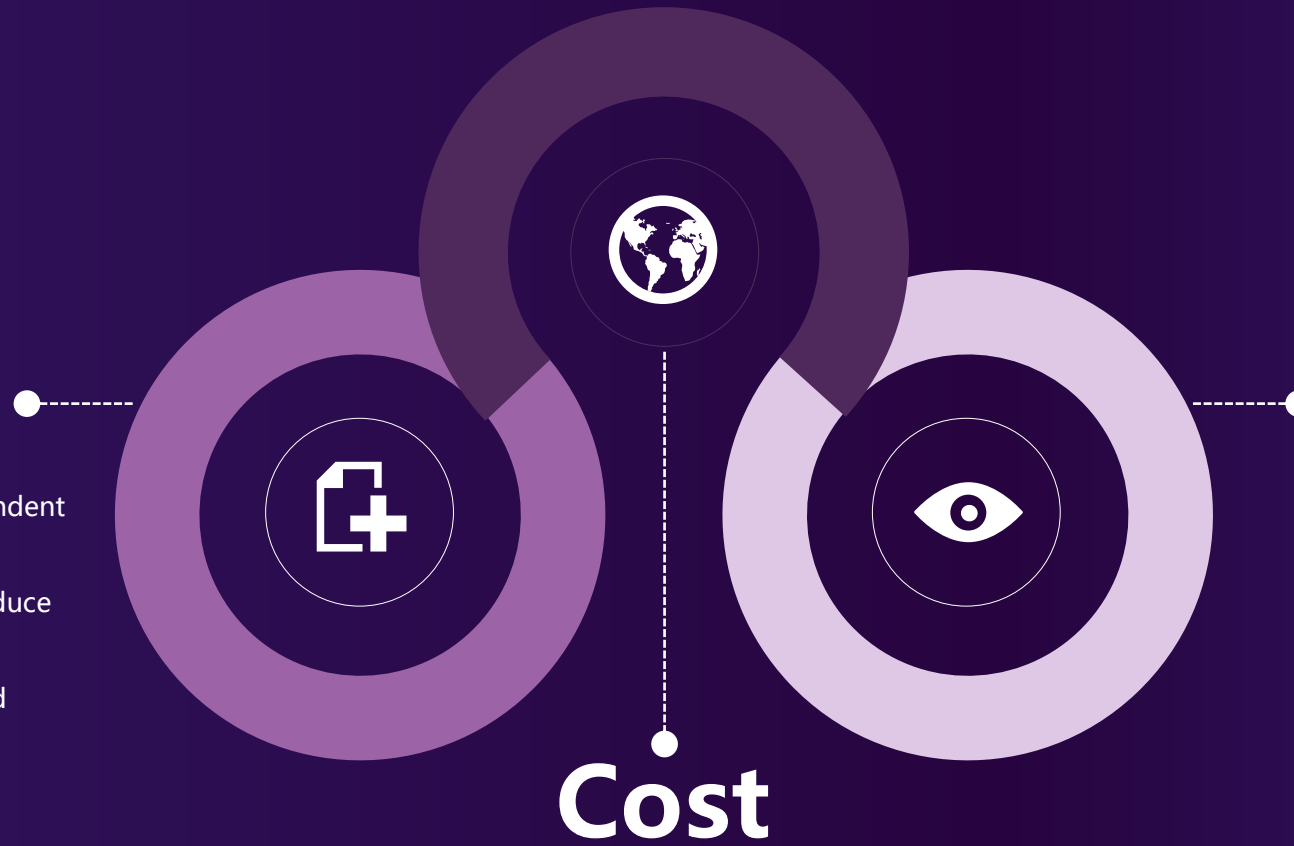


Why Do Companies Need Data Security Compliance?

Who?

- Need to comply with government regulatory requirements
- Need to gain customer trust
- Customer data needs to be protected
- The assurance of a third-party independent compliance body is required
- Ongoing compliance is required to reduce operational risk
- Enterprise data needs to be capitalized



Time

- Financial enterprises need an average of 20 man-months per year to cooperate with or complete compliance audits.
- It lasts 3-6 months.
- The compliance audit report is not continuous and requires manual verification
- Compliance audit requirements need to be updated in light of changes in laws and regulations

Cost

- The average annual compliance audit of enterprises is nearly 3 times
- The average annual consumption is 3 man-months internal costs and 5 man-months external costs

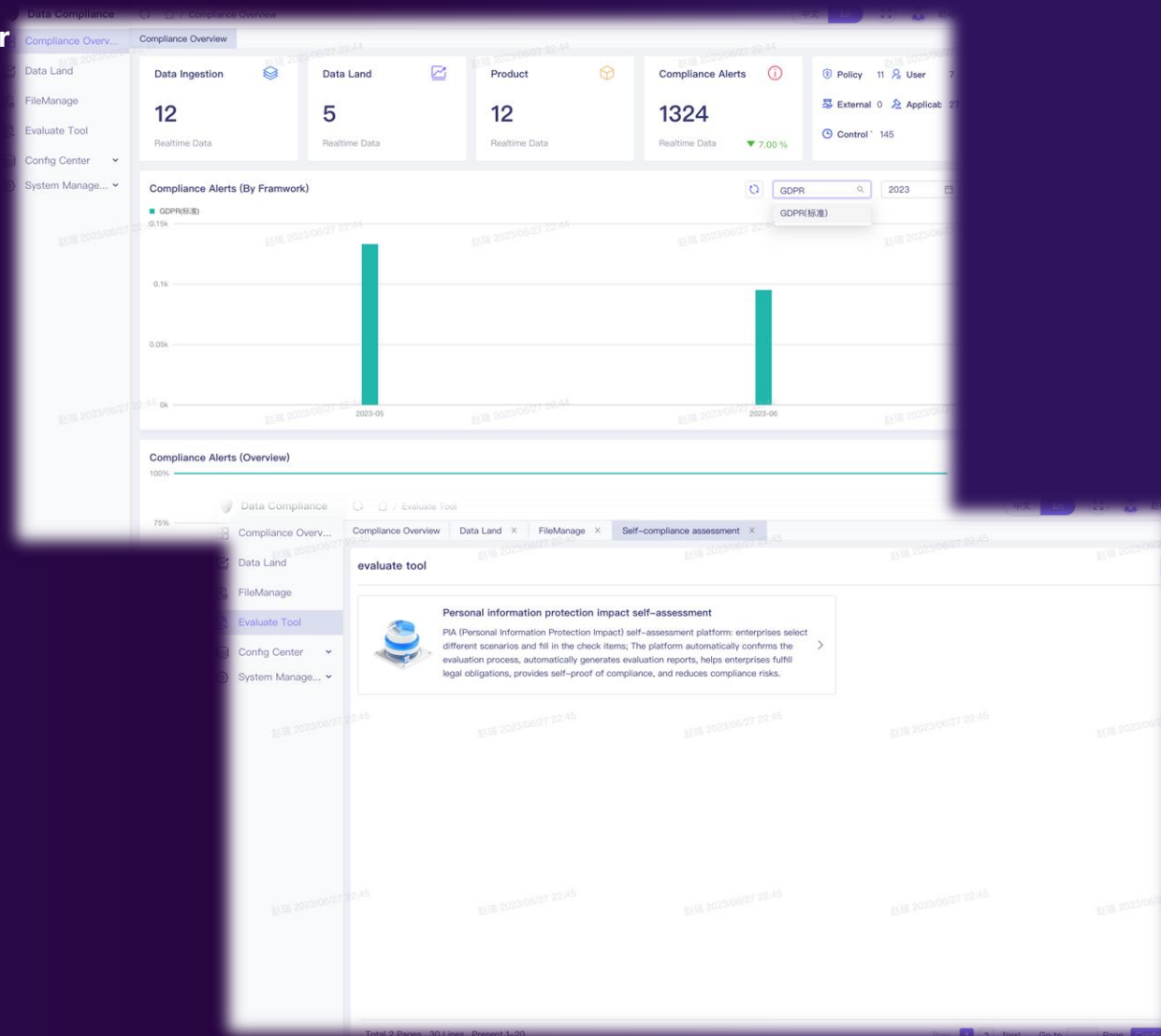

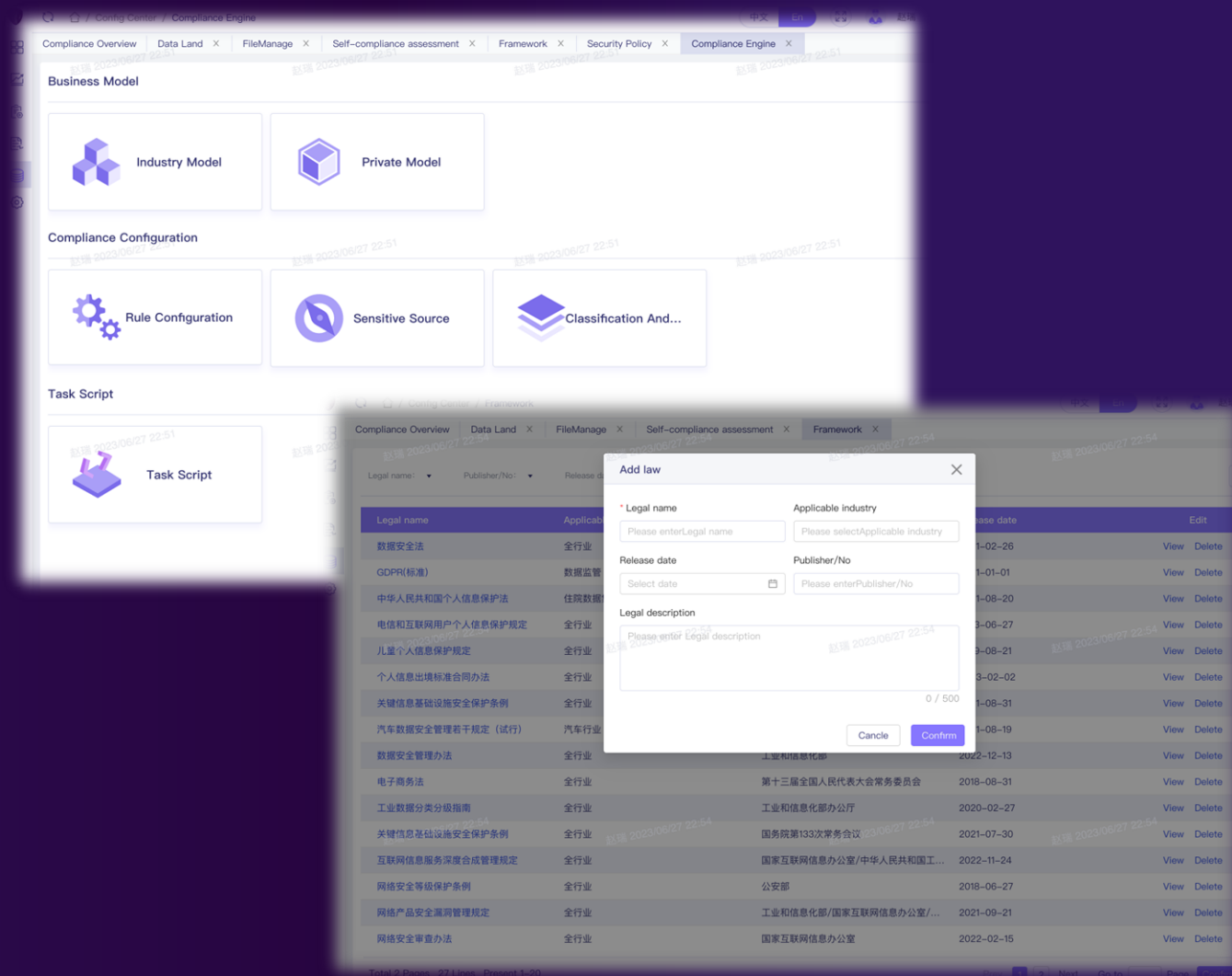

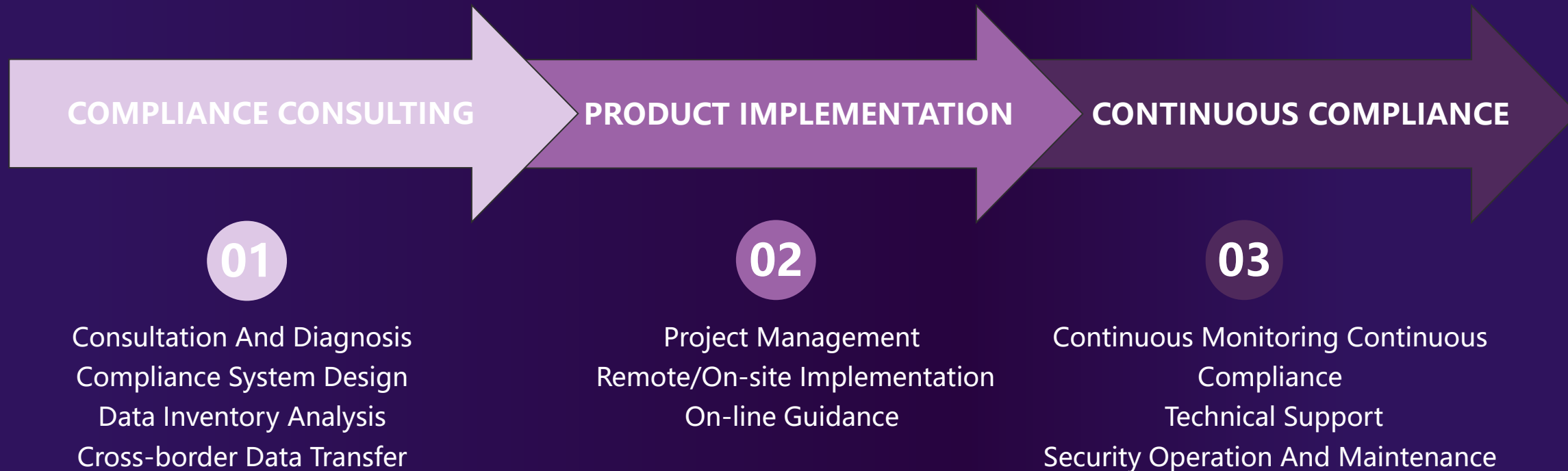
