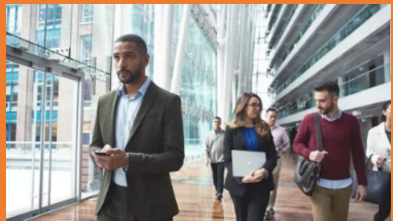

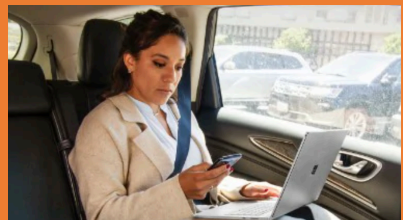

CASE STUDY

UK regulatory authority with over 600 users
