

#### Provider Engagement Program

#### Timely Reviews & Fewer Queries

In a study examining 18-months of aggregated Provider Engagement Program data, Advantasure reviewer and coder teams evaluated the response cycle times of CDI alerts and queries for paper-based versus electronic delivery systems.


The study revealed that on average, electronic CDI alert cycle time was 15 days faster and the query cycle was 27 days faster than the paper-based alternative.

The reduced alert and query cycle time of the electronic platform can be attributed to the efficiency of the EMR-integrated provider workflows and speed of information exchange between providers, reviewer and coder teams.



## CDI Alert Response

CDI Alerts are quick and easy to respond to. As a result, over 75% of CDI Alerts were completed and returned with an average of 75% conditions addressed.





## Stars Rating Improve

Star Ratings improved an average of 5% due to identification of care gaps and supporting initiatives.



## Risk Adjustment Factor Improvement


More complete coding specificity directly impacts the risk adjustment factor. Advantasure's Provider Engagement Program participants experience an average lift of 10-15% on risk scores.
