# Microsoft 365 Assessment

# Challenges:

- Keeping the evergreen M365 platform and services up to date can be difficult

- M365 has been implemented in a phased or ad-hoc approach, with many of these project implementations not following recommended practice.
- Some components such as Teams and SharePoint have been deployed rapidly in response to the pandemic, but have not been implemented securely with appropriate information governance. This puts the organisation at risk when wanting to collaborate with other partners.
- Organisations are using many different software products that can be replaced by M365. The standardisation and rationalisation onto M365 will deliver cost-savings, reduce complexity and deliver improved business efficiencies.
- Organisations are not using much of the capability within the M365 product set, are not sure what this capability is or how it could improve business processes. Some examples of this additional capability include Power Platform, Sharepoint Syntex and Microsoft Viva
- Organisations do not have a clearly defined roadmap to implement M365 functionality and have limited capacity and capability to deliver this change.
- Using cloud-based device management that leverages device analytics and uses Windows-as-a-Service to roll out new feature updates to endpoints
- · Legacy applications support and whether implementing Windows Virtual Desktop provides a reliable and scalable service


