The Agilisys Security & Compliance Assessment is typically a 4-week engagement, and follows a structured approach that starts with a discovery exercise and looking at the existing documentation.

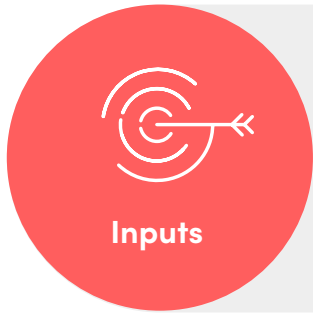
We then engage in further discovery, review of the current tenancies and identify risks and opportunities to improve your organisation's security posture.

By enhancing your security and compliance posture, you eventually lower the risk to your organisation and increase your users' productivity and efficiency.

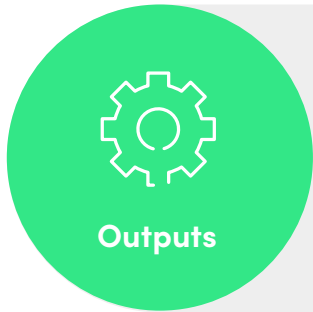
