- Microsoft Teams governance and collaboration
- Records Management and Compliance
- End User Roles and Responsibilities
- Collaboration between all departments using Microsoft 365 with a focus on SharePoint, Teams and OneDrive.
- MS Teams will be leveraged for internal and external use. OneDrive will allow collaboration with external parties/partners when approved.


The following are general recommendations that will allow [CLIENT] to successfully govern their digital workspace. These recommendations include:
