Step One:

Step Four:

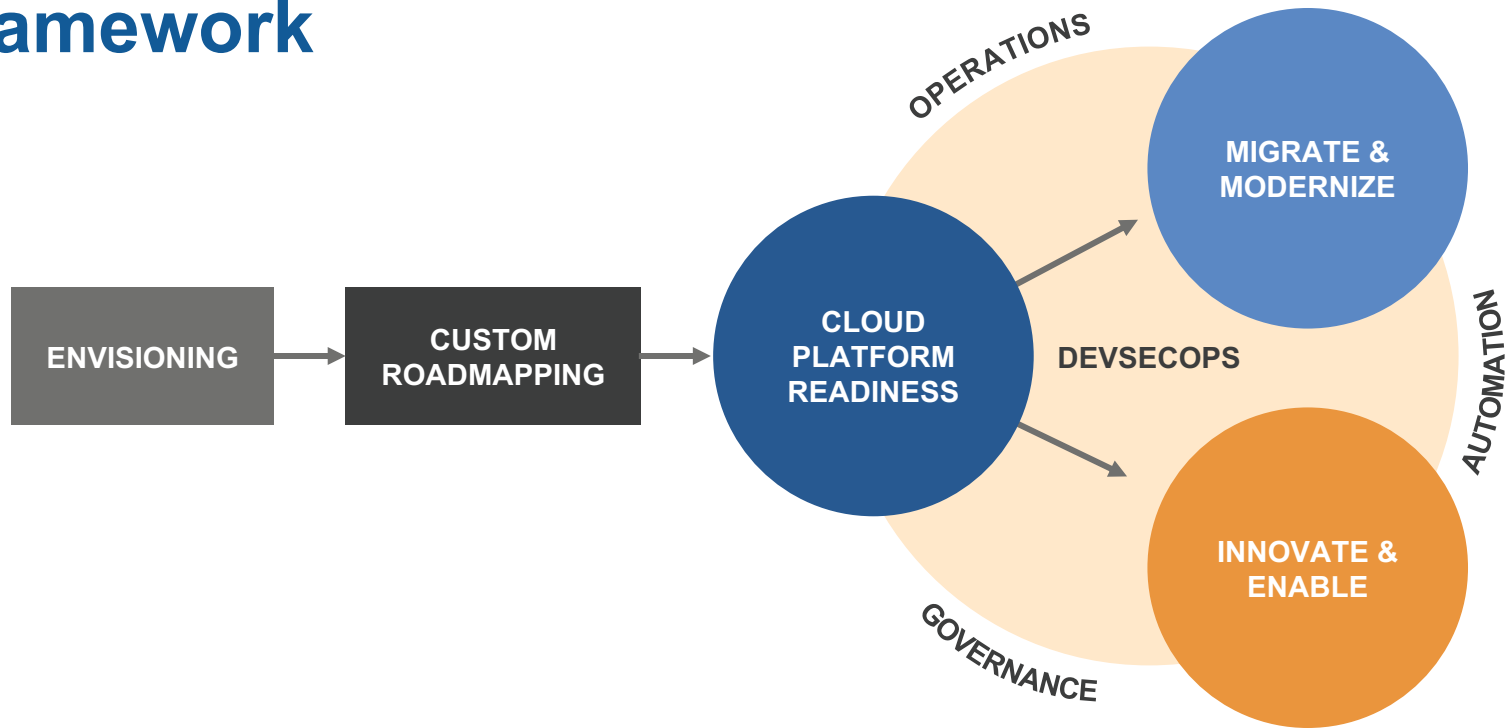
Lead Horse Migration

We'll migrate a proof of concept application to the designating cloud environment using the recommended approach, followed by a phased migration plan.

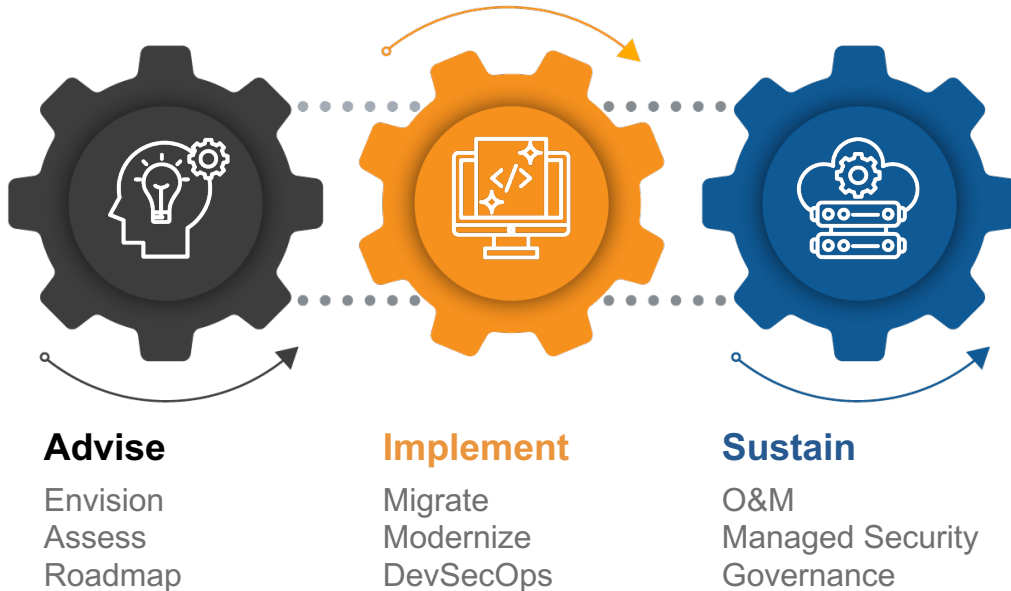
