Key Considerations for Workplace M&A

Below are the 4 key areas of focus when executing a Workplace M&A activity with Microsoft 365





Guiding Principles:

- Determine if legacy devices will be reused or if replacements are necessary
- Determine any device policy differences and updates required, such as for BYOD and corporate assets
- Determine if current device management solutions are sufficient or require updates



Identity

Guiding Principles:

- Determine identity attributes, such as logons and emails based on branding decisions
- 2. Determine authentication methods and additional verification such as MFA
- 3. Establish an identity governance and administration solution



Collaboration

Guiding Principles:

- Define use case scenarios for how collaboration is intended
- 2. Determine what components of collaboration are needed and enable only the applicable collaboration features
- 3. Define external sharing policies
- 4. Provide seamless coexistence during the integration process



Change Management

Guiding Principles:

- Account for end user communications and training to improve their experience
- 2. Prepare the operations team and service desk organizationally as well as technically
- 3. Liaison with the business leads to include LOB involvement
