Global association dedicated to the care for surgical patients, their safety and well-being. The association advances the field of surgery through its various programs, publications, and initiatives

Area of Focus:

 Distributed device security and remote user access

BUSINESS CHALLENGE

- To support the global pandemic, the association's workforce moved to a remote access model, challenging the on prem security systems
- With BDO, the association decided to adopt cloud-based, Zero Trust services for remote access

SOLUTION

- ▶ BDO migrated the association off on-prem Active Directory and into Microsoft Entra, for cloud-based, always available Identity as a Service (IDaaS)
