Regulatory drivers

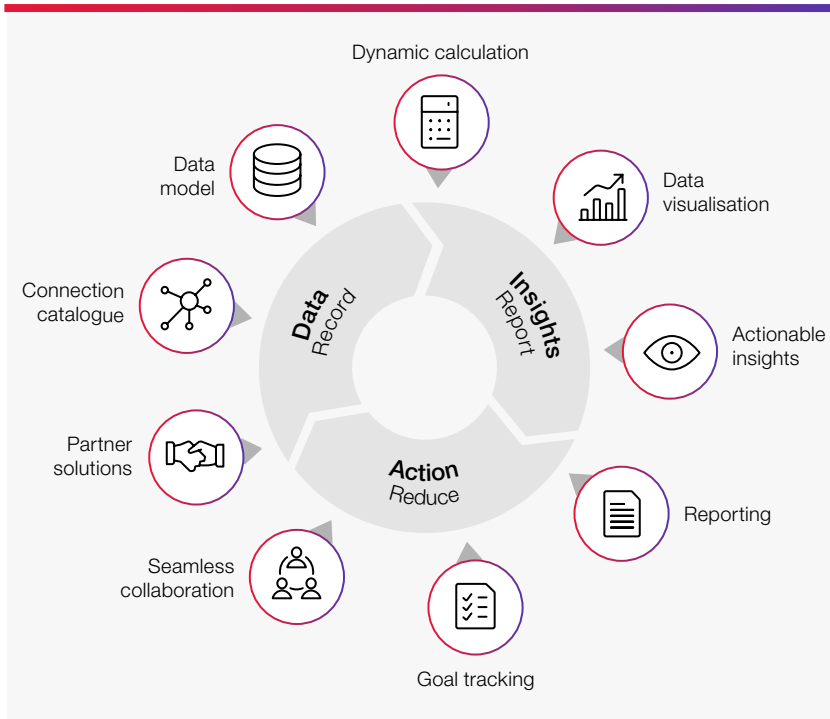
