- Score each dimension.
- Benchmark against industry standards or similar organizations.

Identify gaps. Highlight differences between current and desired states.

- Compare current maturity scores to target maturity levels.
- Identify technology, process, policy, and skill gaps.
- Highlight risks, inefficiencies, or areas of underutilization.
- Document missing governance structures, training, or compliance gaps.

Develop recommendations. Provide actionable guidance to address gaps.

- Suggest short-, mid-, and long-term initiatives.
- Align recommendations to business goals and user needs.
- Categorize recommendations by area.
- Estimate effort, complexity, and impact.

Build roadmap. Translate recommendations into a structured plan.

- Prioritize initiatives using criteria like impact vs. effort, dependencies, or urgency.
- Organize initiatives into phases (Quick Wins, Next Steps, Future State).
- Define timelines, ownership, budget needs, and success metrics.
