OUR APPROACH

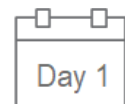
The Service will typically be delivered in 5 days (over a 10-day period) and is characterised in the following ways:

- Includes the implementation of the Microsoft Toolkit



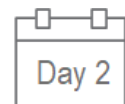

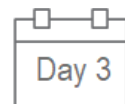
