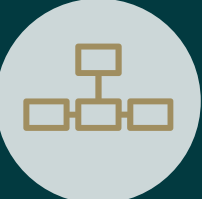

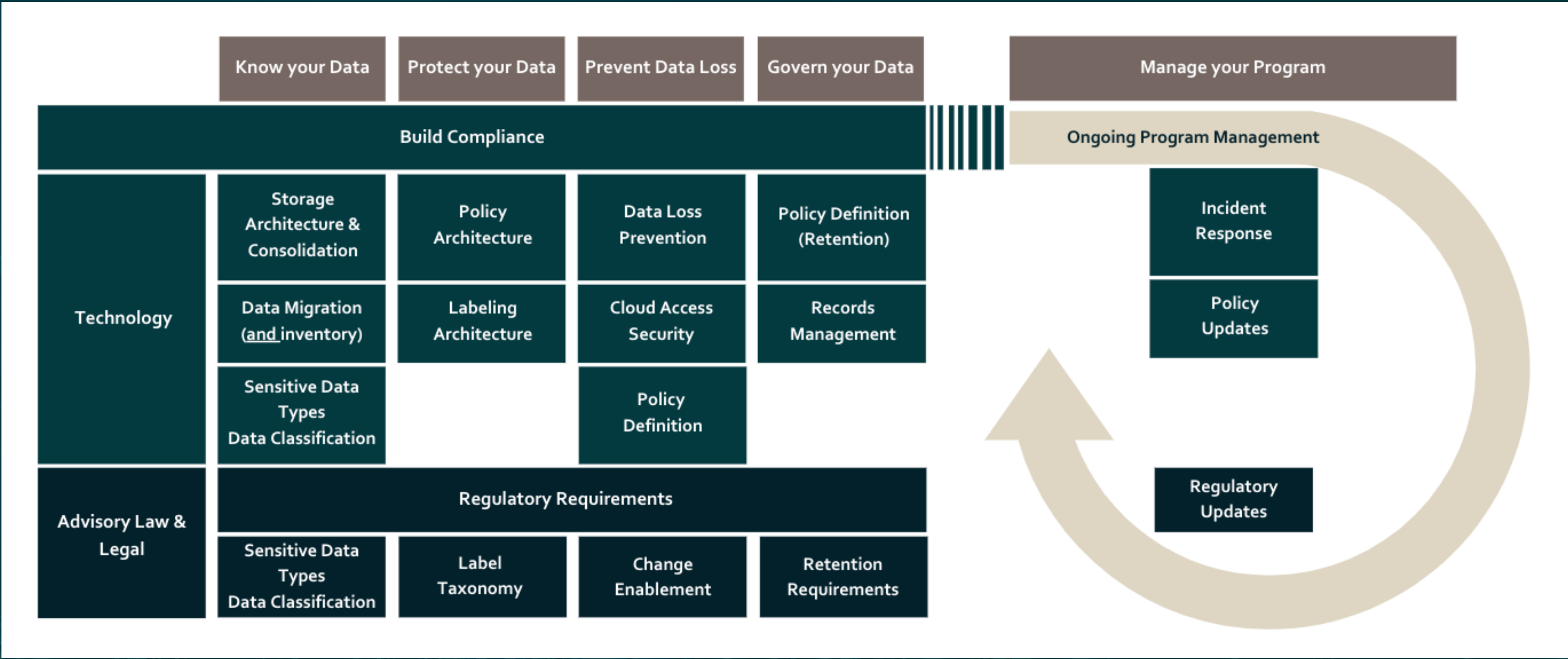

Case Study: **Canadian Consumer Product Distributor leverages Difenda's Microsoft IP&G**

Key Drivers & Business Outcomes

Protecting data and information is a crucial action to take for companies. Consolidating vendors and utilizing the tools you already have is a key step for achieving this goal and one that many protection programs are lagging. This was the case for a Canadian Consumer Product Distributor with a desire to leverage a single vendor for design, deployment, and operations. Their existing solution was nearing the license renewal date, which created the urgency to act ASAP. In addition, the distributor was soon approaching regulatory and audit requirements that put intense timing pressures on their team.

There were many challenges faced by the company, a big one being their lack of budget for security. This was handled by leveraging integration and automation that reduced their efforts and eliminated the need to hire new members. The people, processes, and technologies were now in alignment with compliance requirements, helping to streamline their overall GRC operations. Along with this, new strategic and tactical KPI reporting capabilities for the CSO and compliance manager were added. All of these key implementations increased the ability to handle and control data-at rest both inside and outside of the organization. After roll out was completed, the Product Distributor faced an insider risk attack. With their new capabilities Difenda implemented, they were able to leverage them for a forensic investigation following attack.

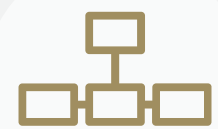

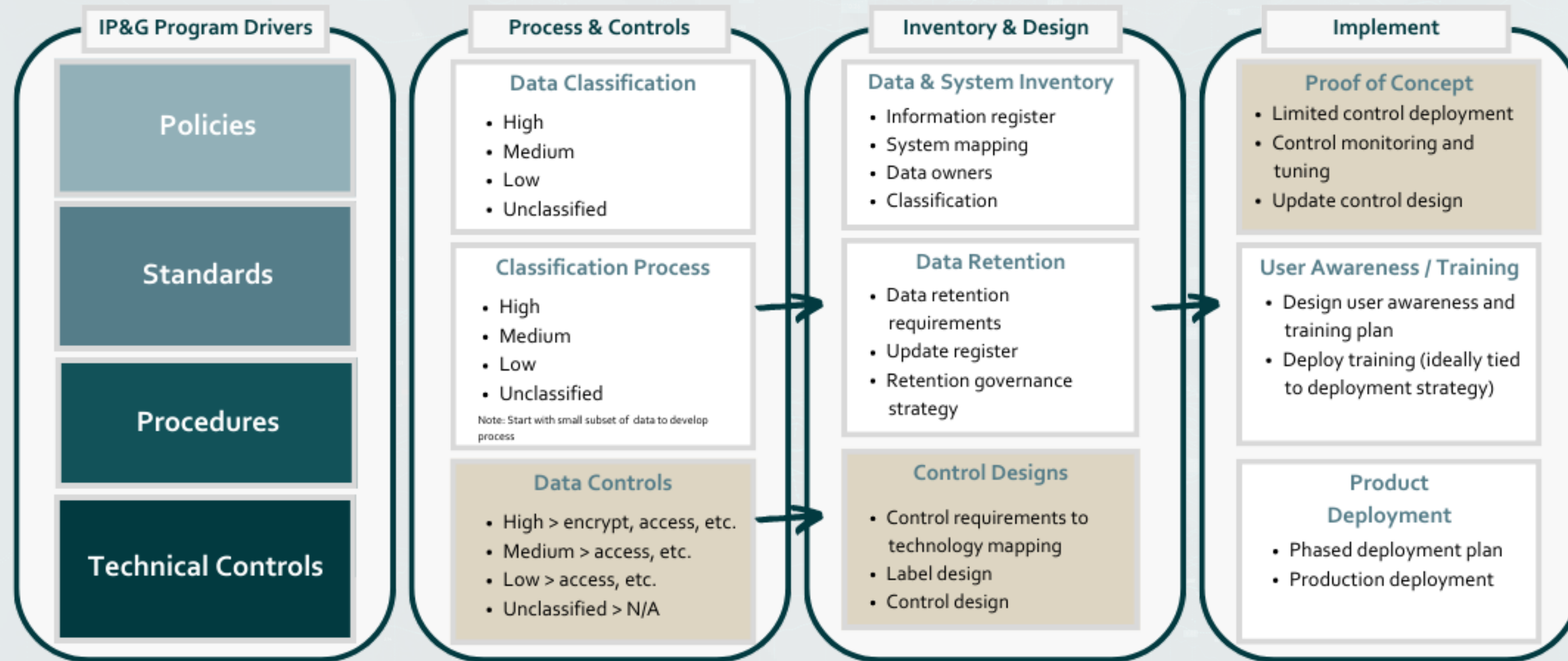
