The anti-money laundering (AML), Know Your Customer (KYC) and sanction laws enacted over the past 70 years created a complex web of overlapping requirements

AML compliance costs rose 33% in 2020 in the US and Canada



Onboarding issues impact productivity and increase customer acquisition cost



\$10 billion in AML fines was paid globally in 2020



The US has the largest number of financial institutions globally



57% of compliance costs are for staffing

It cost US firms **\$35 billion in 2020** to meet these requirements, of which \$10.5+ billion was spent on complying with the customer account opening rules\*
