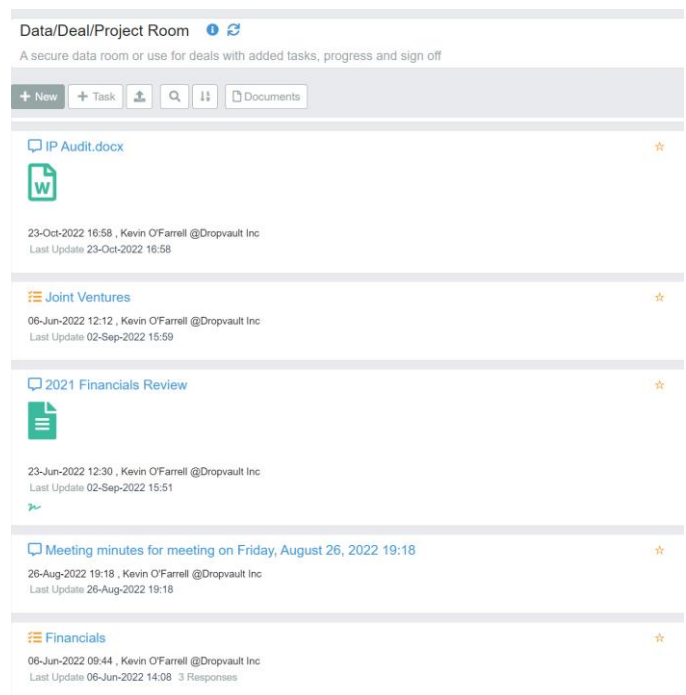


Make your boardroom more productive & private

Keeping everyone on the same page

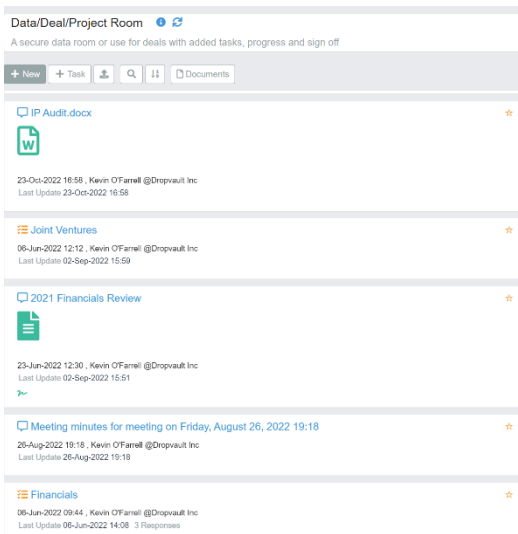

Keeping your conversations and discussions in the same place as your documents not only makes your team more productive, it also ensures privacy and security and makes compliance easy.

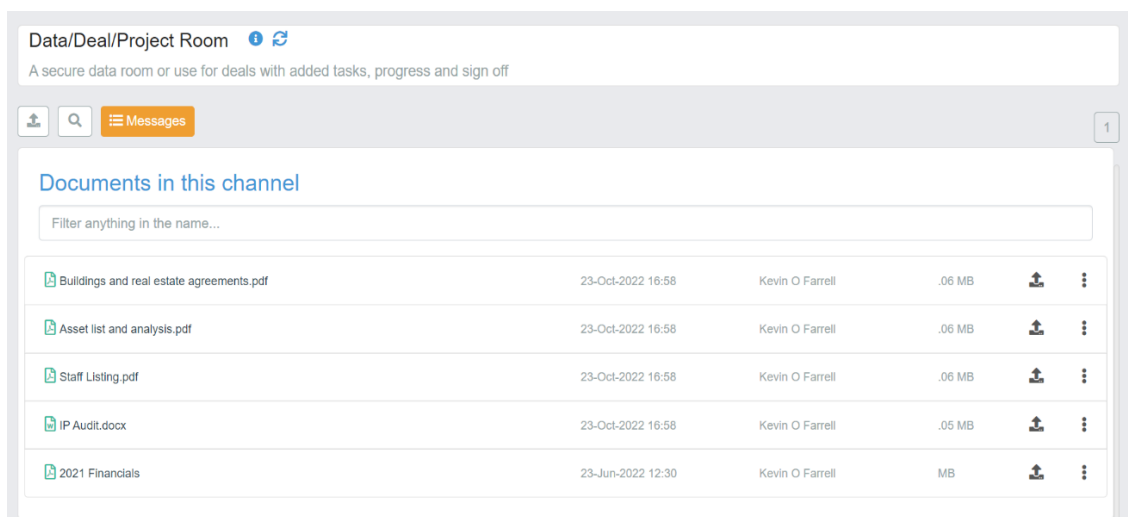
No need to have documents in one place and your discussions in in-secure email – Just start a new conversation or drop in a document and start collaborating as a team.

- Send documents to your board room by email

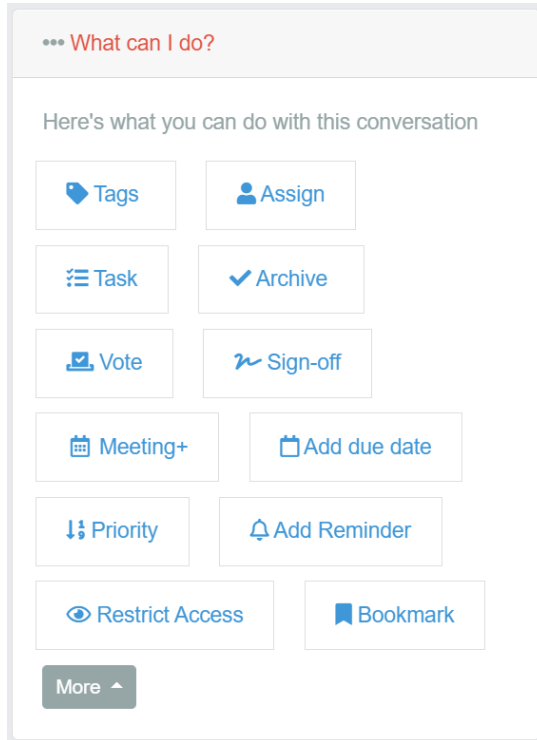
Find & manage your documents easily

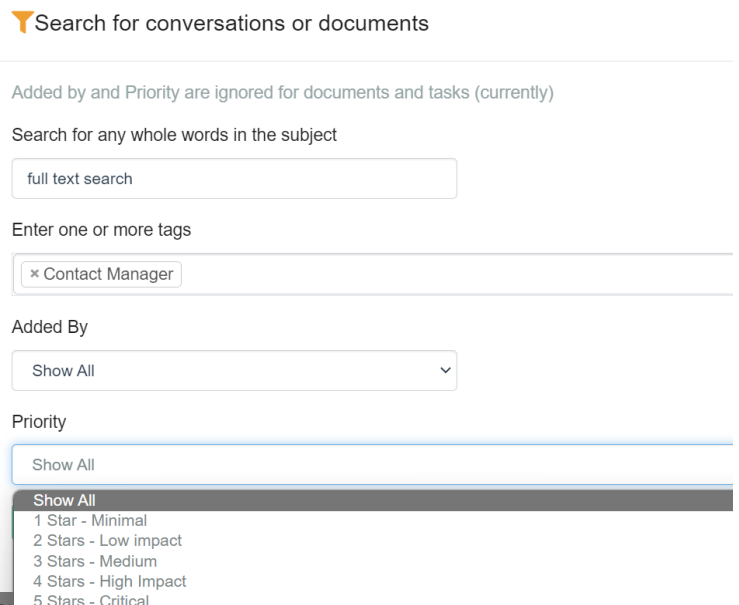
Just select any conversation or document and choose one of the many options available to your team

No two businesses are the same so our data rooms can be set up to work with any business requirements, small or big. From custom storage, to email servers and enterprise key vaults – Or just choose the default settings and be up and running in less than 5 minutes

- Our Board rooms are delivered as a web app – All a user requires is a browser to access and nothing to install
- Full auditing and compliance reports – See who shared what, when and to which team member or contact
- Quantum-safe encryption on every document, every message.
- Each room is secured with a strong 256 bit encryption key
- External teams or contacts can connect directly to your data room with a link you provide. Key is never shared.
- Custom Storage - Cloud default or your corporate AWS, Azure or MINIO On-premise storage for all your documents

We have no access to any conversation or document you share in your Board Room. And if we can't access your data, then neither can an attacker.
