

e-Invoicing in KSA has become mandatory for a list of companies.

Zakat, Tax and Customs Authority (ZATCA) is obliging all businesses to submit electronic invoices to the Fatoora portal of ZATCA and is responsible for the setup and control of the e-Invoicing clearance system. It defines e-Invoice as a digital document proving transactions of sale of goods and provision of services.

How does the new e-Invoicing system in KSA work?

Companies to use the electronic invoicing system in KSA will be required to register with the system by contacting ZATCA. After successful registration, the client information will be provided to transmit invoices and receipts in XML data format. The system (Fatoora Portal) will validate invoices that have been issued.



ZATCA ONBOARDING OVERVIEW

As part of the phase 2 e-Invoicing process, The Zakat, Tax and Custom Authority (ZATCA) requires its taxpayers to onboard their Invoice Generation Solutions (ERP/POS) onto the ZATCA's e-Invoicing portal.

In Ramz Plus solution, we have systemized and simplified this process. Following is the stepwise representation of the onboarding process to be followed.


High level Process Steps

The following process step diagram represents the high-level process sequence that is followed for onboarding the taxpayer's solution ID.

1. Create an account on the ZATCA e-Invoicing portal.
2. Register your EGS / Device on Ramz Plus.
3. Obtain OTP from ZATCA.
4. Onboarding the EGS / Device with ZATCA.
5. Start generating and submitting e-invoices to the ZATCA e-Invoicing portal.



DEVICES (EGS) ONBOARDING WITH ZATCA






DOCUMENTS TYPES (B2B/CLEARANCE)

Standard Tax invoice generation






DOCUMENTS TYPES (B2C/REPORTING)
