

# Rm Risk & Monitoring

Define risk limit policies, analyse non-financial risks across multiple parameters and track limit breaches and utilization as per regulatory and leading voluntary/corporate standards.

## Challenge

Markets are characterized by risk, volatility, and complexity. Controlling risk is imperative, but risk information resides in disparate sources within the enterprises. This information regarding sustainability parameters must be aggregated and analysed to define risk policies.



## Solution

Eka's Risk and Monitoring App for sustainability, lets users define risk policies and set limits against any important ESG metrics such as emissions, waste & effluents, OHS, Governance, and employee diversity, and any activity that needs to be tracked. This application allows users to run risk valuations, interpret risk breaches and get notifications. It allows users to create and manage their risk policies. Users can subscribe to risk breach notifications that alert them of the breaches on a real-time basis. Risk and Monitoring app also allows to view the output of risk engine for all collections and datasets, so that the users can roll up, filter, and build their own dataview and insights. This will cover the policy name, the current value of the measure, dimension values of the limit, limit value, and breach value.

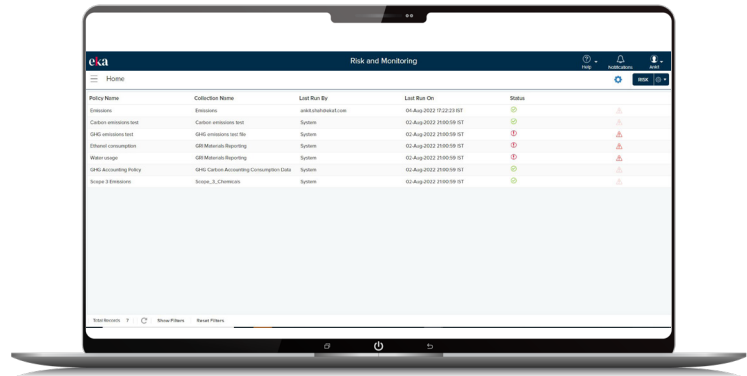
