## Solution overview

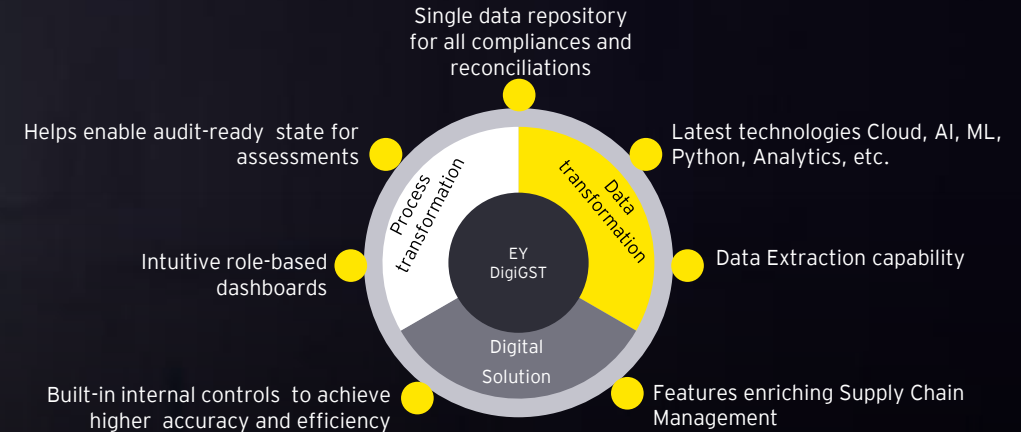

- ▶ Intuitive MIS reports for monitoring business critical values (tax liability paid, credit availed, top vendors and customers, top products)
