- MRZ check (Machine Readable Zone)
- Application of the risks levels based on internal strategic information to all the operations.
- Expiration Date of the document and its validity.
- Validity status of the foreign driving license in Spain.
- Ultraviolet reaction of the physical support \* examination.
- Comparison between the VIZ (Visual Readable Zone) vs. MRZ (Machine Readable Zone).
- Expert assessment on forgery patterns of visible, ultraviolet and infrared light
- Issuing date verification.
- Validity check with the issuing authority. \*\*
- Personal data and its congruence verification.
