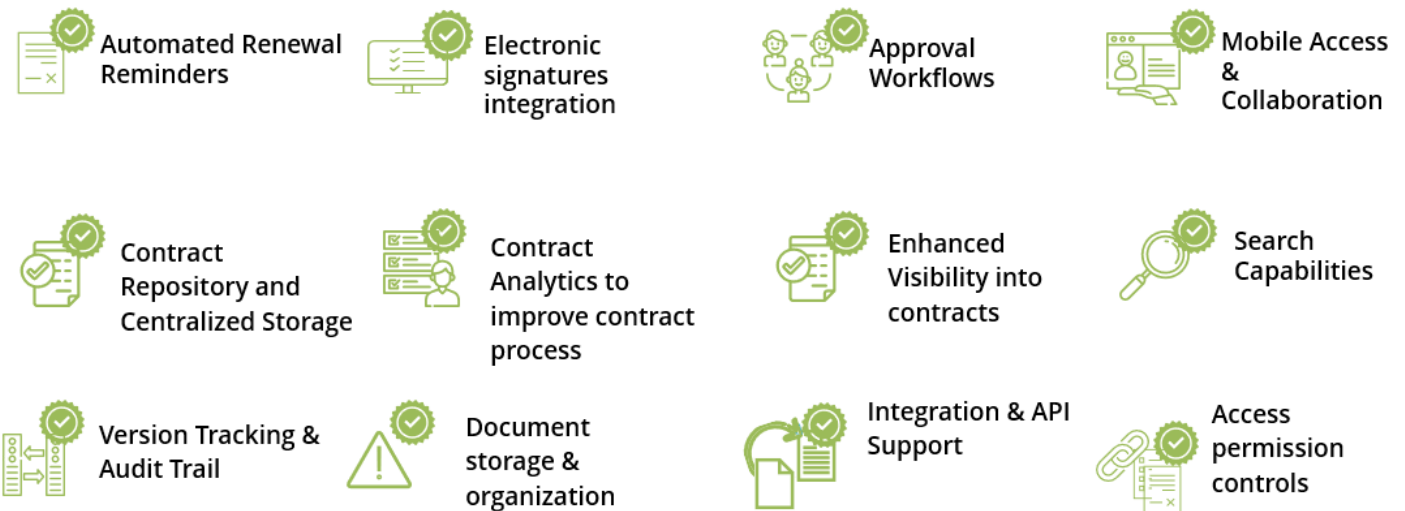
1.3 Benefits
