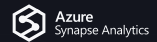

Security & Data Access Control

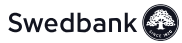

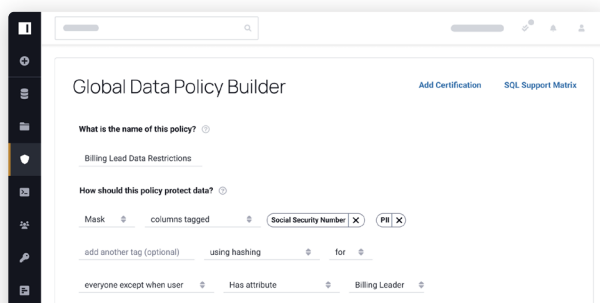

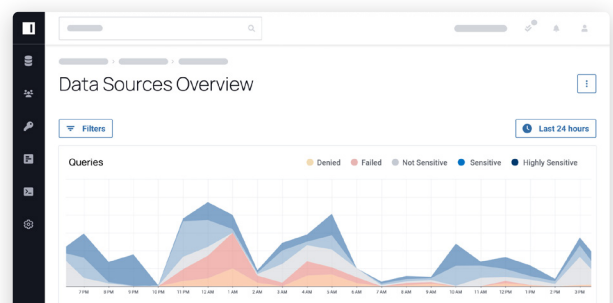
