Background

TISAX (Trusted Information Security Assessment Exchange) is a European automotive industry-standard information security assessment (ISA) catalogue based on critical aspects of information security such as data protection and connection to third parties. This certification will become mandatory for all suppliers to the German automotive industry.

For example, ZF and BMW specify that all business partners must have implemented an information security management system following TISAX. Volkswagen even explicitly requires TISAX certification. Large suppliers such as Continental pass on these obligations to their partners to offset the threat of significant contractual penalties.²
