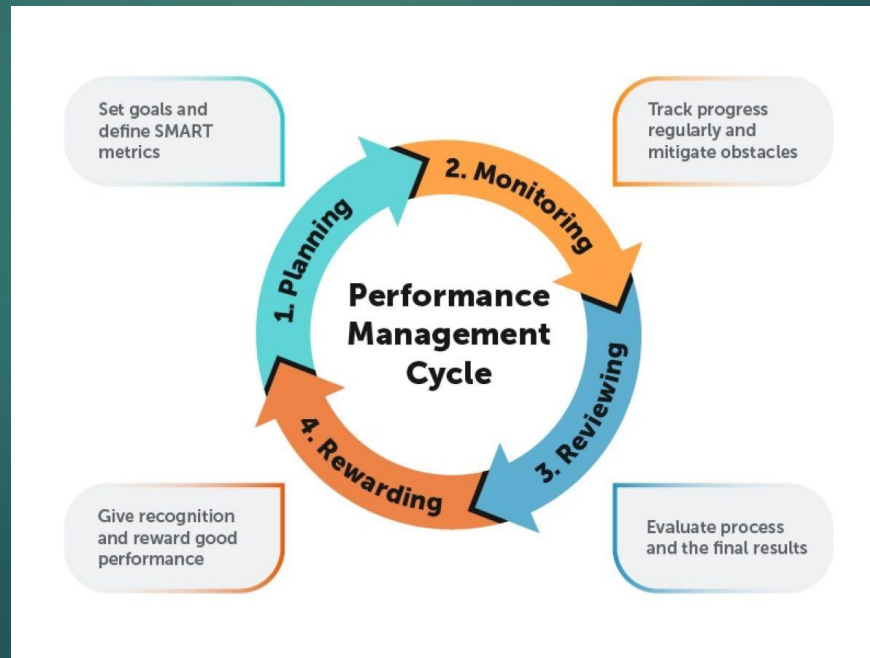
Entry/Exit Point CCTV Monitoring

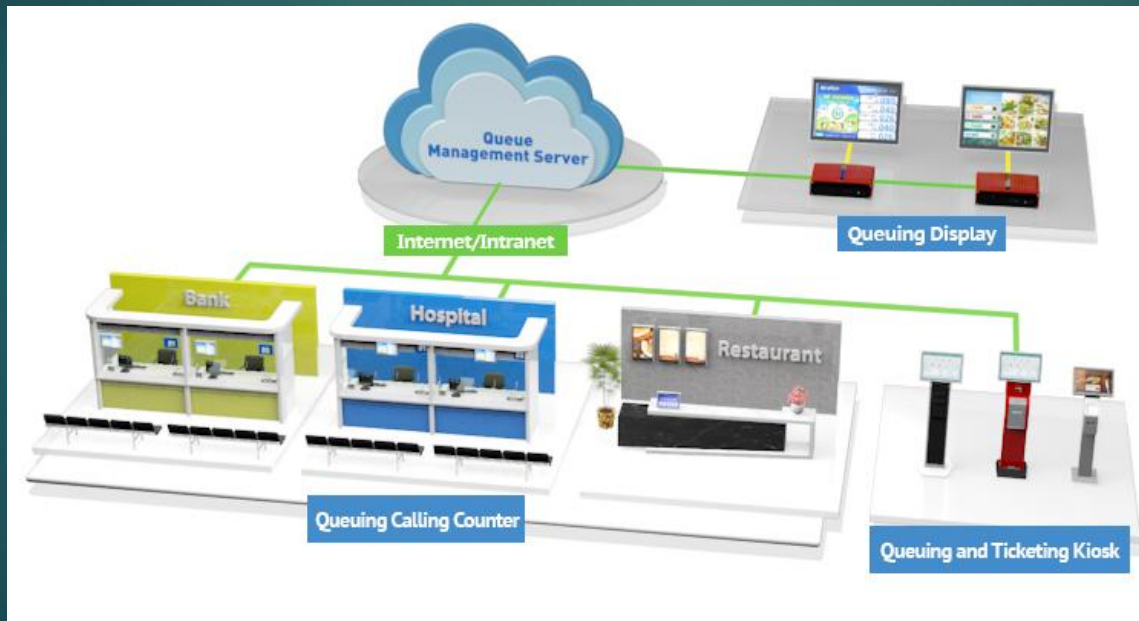

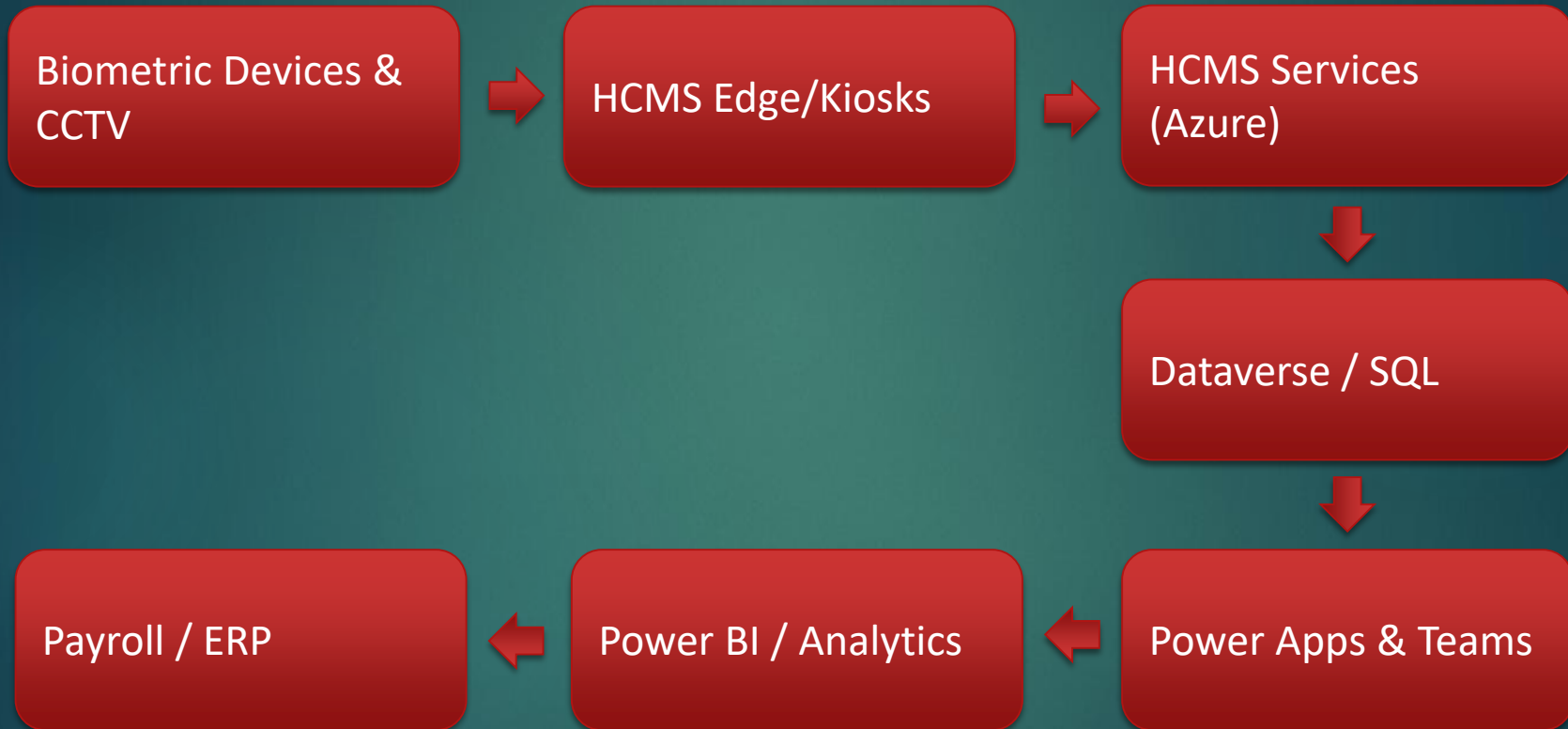
