Here are some of the key aspects of our Microsoft Power Platform Al Accelerator:

Microsoft Technology:

Kainos have developed an AI accelerator that demonstrates the ability to classify emails received from customers, triage emails and draft initial responses via AI. It's built using Microsoft Power Platform, Azure AI Services and OpenAI.

Email Management, Control & Secuirity:

Microsoft Dataverse powered Al accelerator. Provides the underlying data infrastructure to securely store, manage, control access & retain data (i.e. emails, attachments, docs). Incl. authentication via AAD (Azure Active Directory).

Al Enabled Classification, Triage and Response:

Enabled use of Azure AI Services and OpenAI to classify, summarise and extract key information from mail requests, automate workflow and triage emails to business team(s) and generate AI email draft response for review and issue.

Out-of-the box MI and Reporting:

This accelerator offers Out-of-the-Box (OOB) MI, reporting and analytic capabilities. To support email management for business team(s) and/or their leaders. Incl. seamless integration with real-time Power BI reporting (as required).

Straight through Email Processing:

An ability to facilitate 80/20 (or more) straight-through-processing based on common email requests and queries. To reduce manual effort and cost, whilst driving efficiency for business users through their investment in Power Platform.







Power Platform Shared Mailbox Solution

Significant backlog of unanswered emails, mailbox receives **2,000 emails** per day. **80 staff** who access this mailbox at any one time, exceeds limit for concurrent users resulting in:
