





# OUR HISTORY

Deallink started by the idea of three investment bankers whom were tired of paying abusive prices, outdated platforms and unnecessary functionalities.

After conducting an extensive market survey, the three friends realized that there was room in the market to improve and decided to take the idea to the next level.

The results of the survey were surprising. 287 legal and financial advisers were surveyed. 82% reported they never used search functions.


The number went up to 87% taking in consideration the ones that used but did not search over 5 words.

The survey also showed that 92% never bothered to use the Q&A, as they reported they were most often complicated to comprehend how the functionality worked and usually opted for the traditional spreadsheet.

After the results of the 1st survey, we concluded that a 2nd survey was needed to really understand what these professionals were looking for in a virtual data room.

After the results of the 2nd survey, we realized that the success of the transaction, when utilizing a virtual data room is in the hands of the external users (buys side users).

With that in mind and not forgetting the most commonly used functionalities like reports in real time, Q&A forum and etc.., we developed our platform focusing on the experience of the external users. In other words, we developed our platform with the success of the transaction in mind.



## **IMPLEMENTATION**


