What data do we collect?

How do we collect your data?

You directly provide Maaind with most of the data we collect. We collect data and process data when you:

- Use or view our website via your browser's cookies.

Maaind may also receive your data indirectly from the following sources:

How will we use your data?

What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

Functionality - Maaind uses these cookies so that we recognize you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.

Advertising - Maaind uses cookies to gather data on your website visit, including viewed content, followed links, and device/browser information.

To enhance your website experience, we utilize Google Analytics and HubSpot to comprehend how visitors discover our site and track their navigation for improved service. When you submit a form, such as providing your name and email, the data is securely stored in HubSpot CRM, serving the specified form purposes. Opting in allows us to use your information for additional communications, like Email Newsletters or Marketing Emails, sent directly from our CRM system. You can unsubscribe anytime through the link in the newsletter or by emailing us. Contact form and email data are directly entered into HubSpot CRM.

For visitors opting in, marketing communications will only occur post explicit consent. Individuals under 16 need parental approval for submitting data.

Do we ever share personal data?

We do not share your personal data with other third-parties other than data processors as listed below.
