

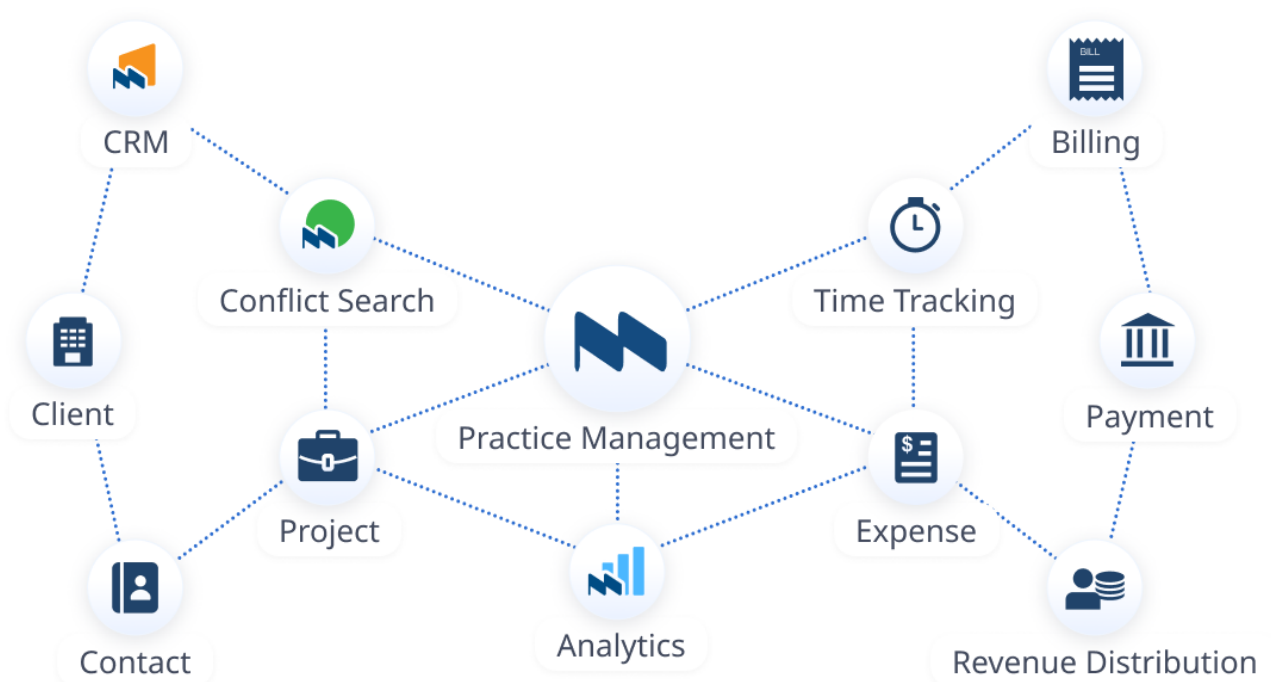

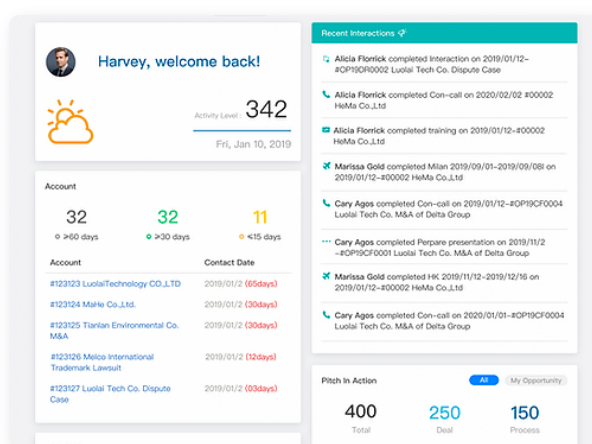

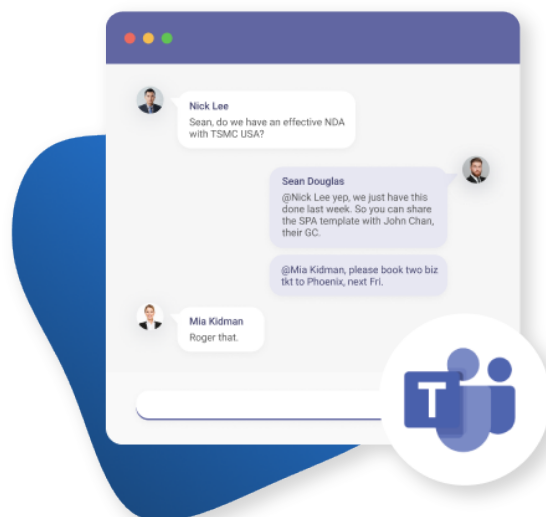


Tracking Anytime & Anywhere

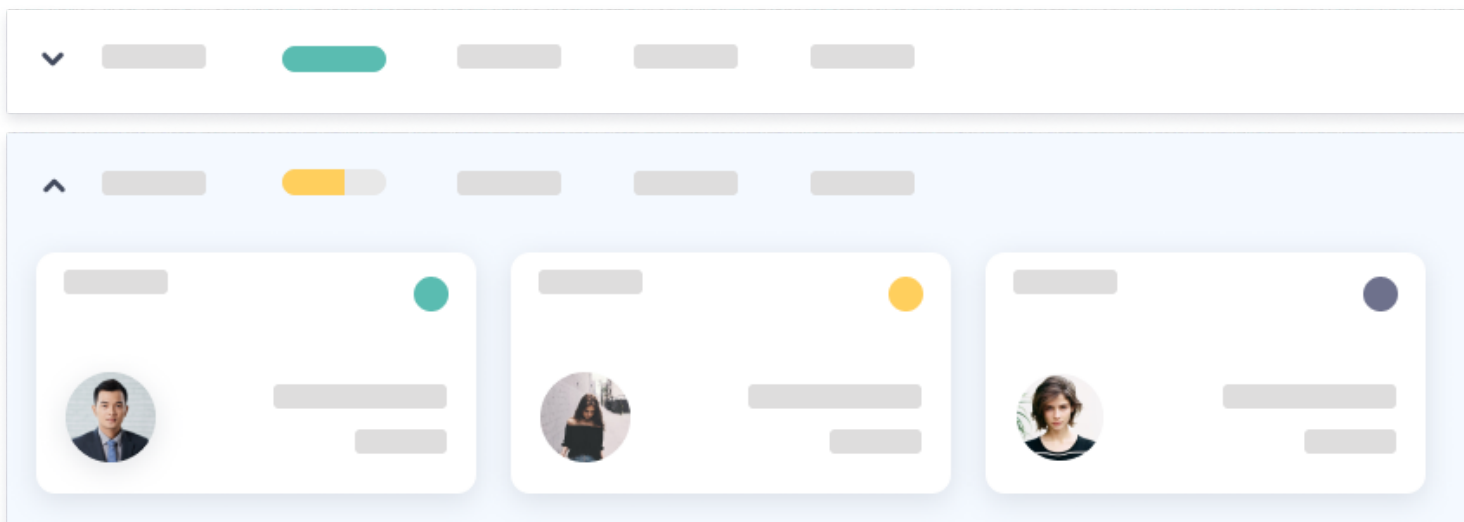
Project Management

Milestone & Task Management intuitively define the project schedule in phases. The team can quickly understand the progress and identify any risk, or pitfalls.

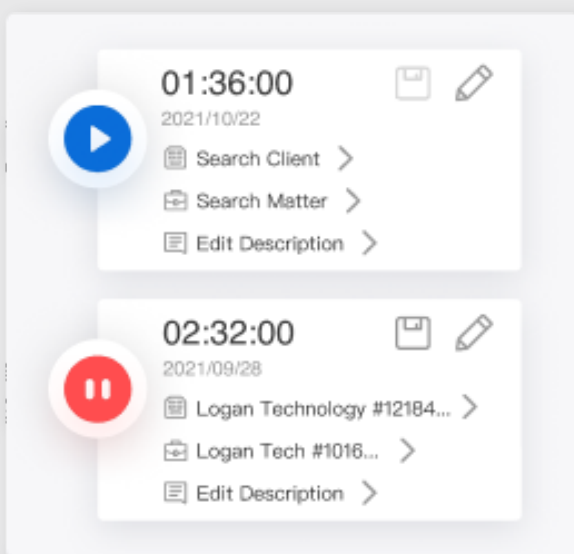
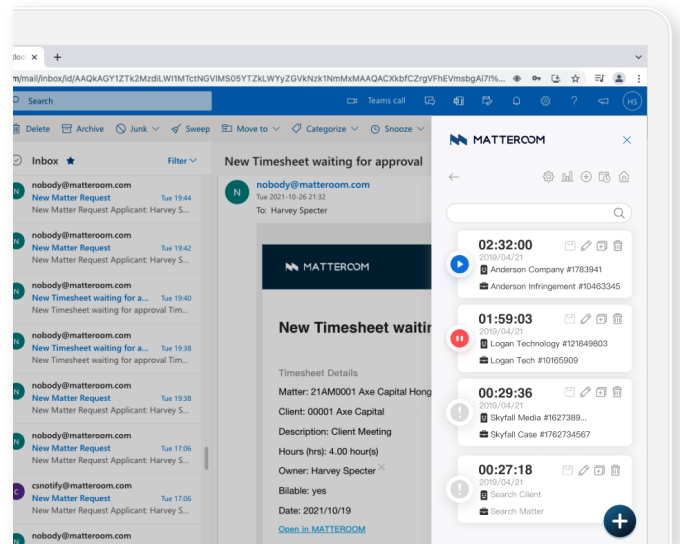

■ Clock Anywhere & Anytime

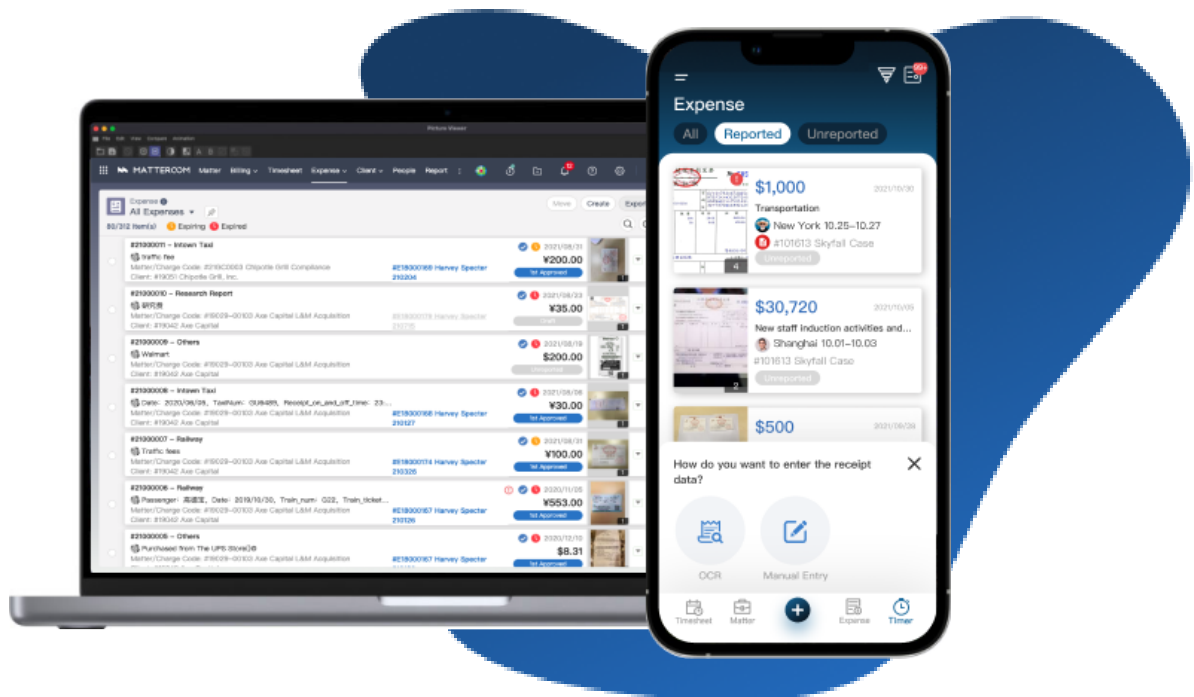
Timekeepers can clock anywhere and anytime using our mobile app and Office Add-on. The clocking feature is device-independent and works across platforms.

Expense Management

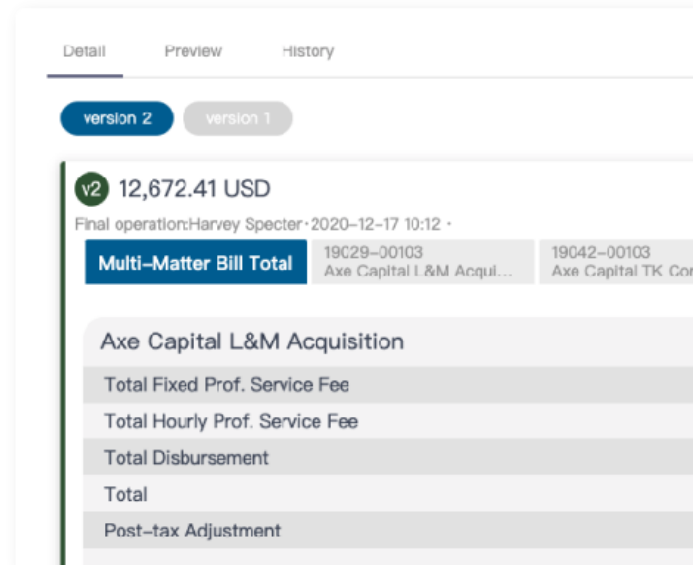

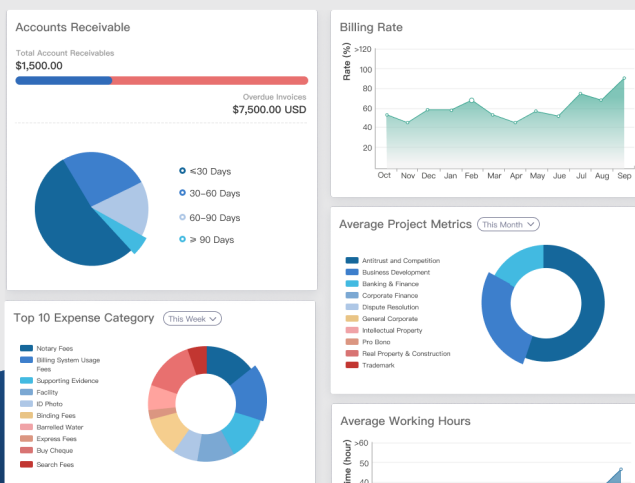
Versioning

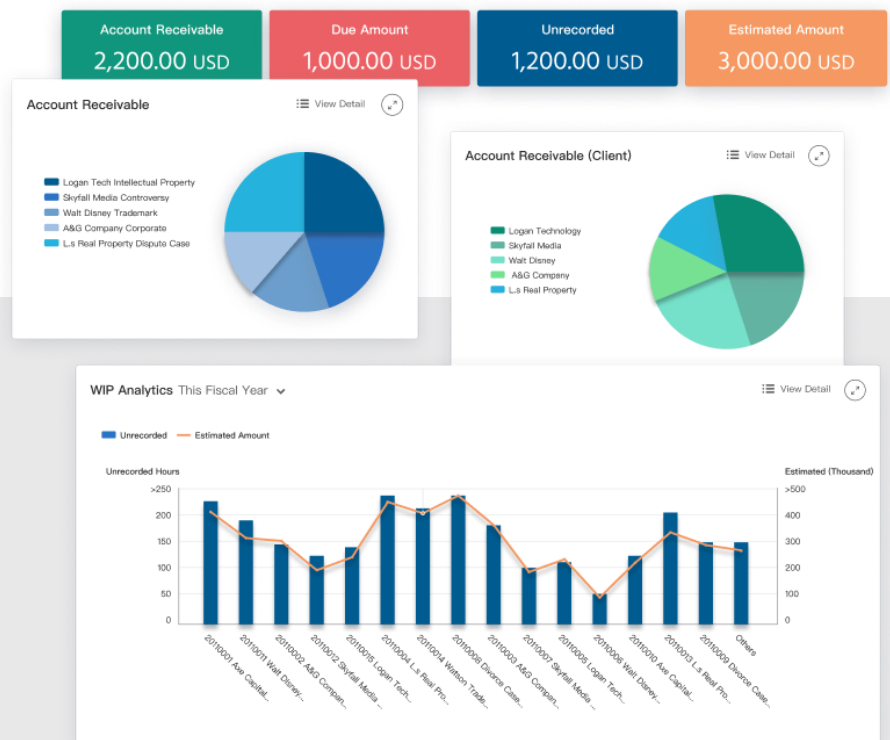
Visualization
