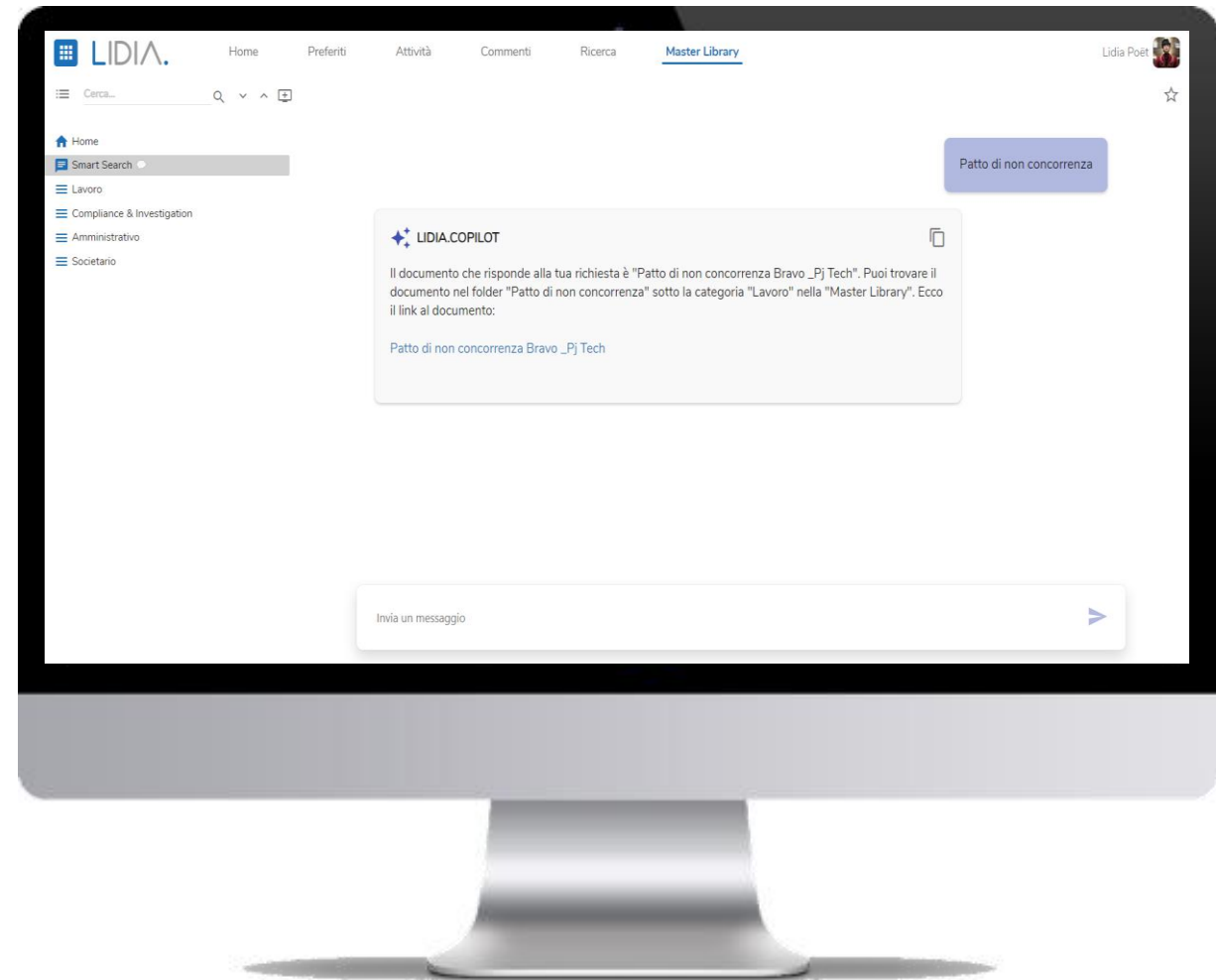
LIDIA **categorizes and classifies the entire document system** based on a customized taxonomy.

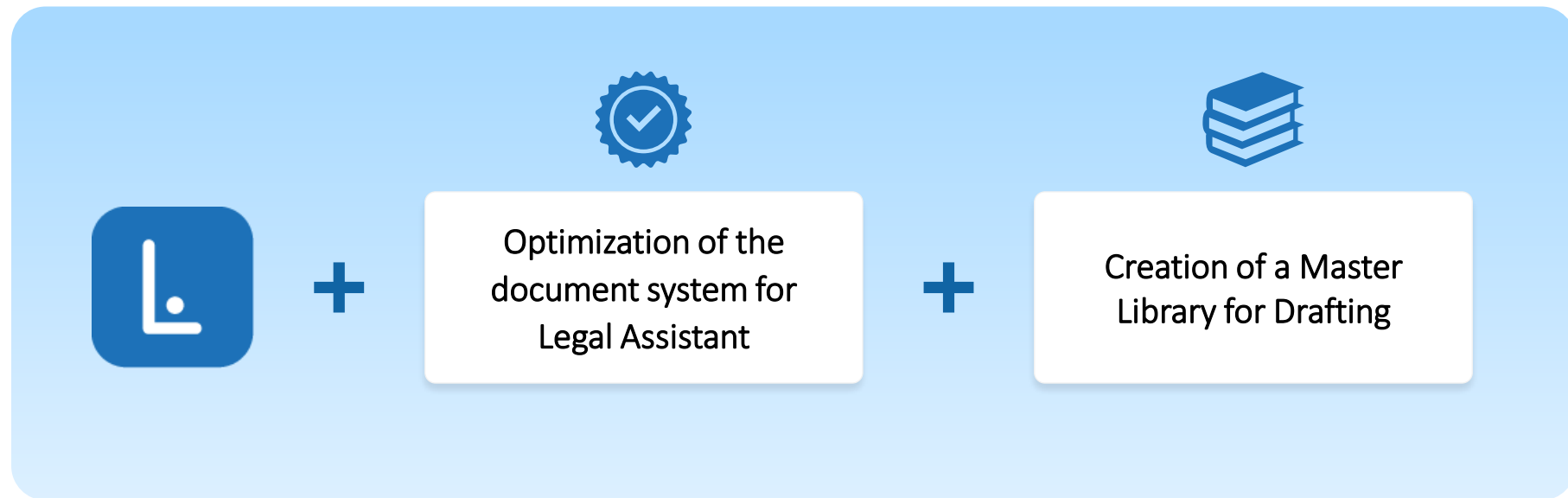

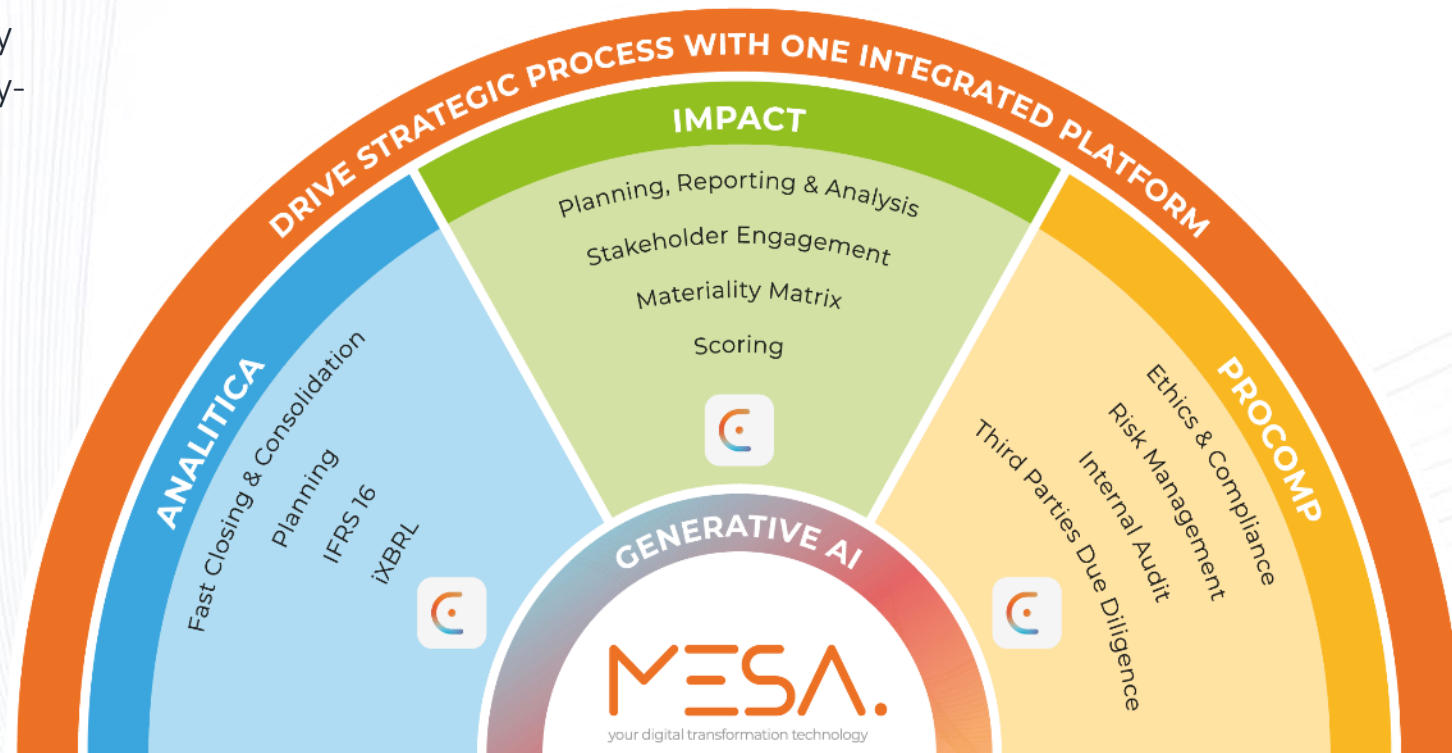
