Universal Marketplace Suite

Helps create markets that facilitate price discovery, allow matching between buyers and sellers and support the integrity of the market.

Listing

Service that enables assets to be catalogued and made available for trading

Pre-trade Risk Management

Risk management service that provides guard rails preventing risk limits and tolerances from being breached in order to help ensure continuity and prevent disruption in the marketplace

Matching, Including Market Operations Support

Asset-agnostic matching capabilities that enable trading of many types of goods, services, and assets

Market Surveillance

Market monitoring service enabling identification of manipulative behavior to proactively protect market integrity

Data Discovery

Service that normalizes data and enables query and reporting across cross-silo data to gain insight into data patterns and trends

Digital Assets Suite

Manages the complete digital asset lifecycle from price discovery and matching through the issuance, settlement and custody of tokens on a distributed ledger.

Issuance

Creation of digital and tokenized assets on a distributed ledger

Matching

Order management and trade execution tightly integrated with the distributed ledger

Settlement (Delivery vs Payment)

Enables immediate settlement of trades and can ensure cryptographic assurance of Delivery vs Payment of tokens residing on the ledger

Custody

Record keeping of ownership (assets and funds) on a distributed ledger

Data Discovery

Service that normalizes data and enables query and reporting across cross-silo data to gain insights into data patterns and trends
