Privileged Identity Management	Just-in-time access and monitoring for admin accounts to reduce risks.
Identity Protection	Detects risky sign-ins and compromised accounts with machine learning.
Access Reviews	Regular validation of user access to ensure least privilege and compliance.
Password less Authentication	Windows Hello, FIDO2 keys, and Microsoft Authenticator to remove password risks.
