

#### STANDARD ANPPLICATION

The Shareflex Contract solution is a pre-configured standard application for professional contract management in the cloud. Eight different contract types are already included in the standard product. The integrated workflow management system Shareflex Flow is also part of the product standard, with which rule-based as well as ad-hoc workflows can be defined and executed. The system is available in English and German.

The solution can be deployed quickly and integrates seamlessly with your existing Microsoft 365/SharePoint online infrastructure. No additional servers or IT infrastructure components are required. All created contract data and documents remain secure in your Microsoft 365 tenant.

Shareflex Contract is based on Portal Systems' Shareflex ECM Online product suite and can be easily extended with additional components such as electronic file management or workflow-based, standards-compliant document management.

In the following chapters we will introduce you to the different components of Shareflex Contract, the solution for contract management.






# WEB-BASED, USER-FRIENDLY INTERFACES

By default, Shareflex Contract offers user-friendly interfaces optimised for SharePoint Online. All information and documents associated with the contracts to be managed are clearly arranged and available at a glance.

As a result, the operation of the contract management system is easy to learn and does not require any extensive training.






# DEADLINES, DATES AND NOTIFICATIONS

Shareflex Contract makes it easy to record and manage contract periods, dates and reminders. Dates and cancellations are automatically calculated as part of the solution. The graphical representation of the contract term and notice period is an excellent supplement to the date information.

Standard contract periods can be entered, as well as individual periods. An integrated notification system informs via email before deadlines or tasks are reached. In the same way, other tasks for the contract can be entered manually and/or based on rules, so that deadlines during the year can also be managed by the system. Where necessary, these tasks can also be synced with Outlook tasks using SharePoint Online.

#### FLEXIBILITY AND EXPANDABILITY

You can adapt the contract types supplied with the basic system to suit your business needs at any time, or extend the contract management to include other contract types.

An integrated form designer helps you customise the user interface. Business administrators can also easily and flexibly assign permissions using an integrated permission editor. Simple roles and rules as well as complex authorisation structures can be mapped.

All changes to the contract management, the user interface, the authorisation rules and the background processes can be made while the system is running. This means you are always flexible and can adapt globally deployed systems to suit your business. The system grows in sync with your business needs.

#### **CONTRACT RELATIONS**

Shareflex Contract is a powerful tool for the transparent management of a wide range of contract relationships. There are many different use cases for contract relations. The three most important scenarios are as follows:

#### CONTRACT IS REPLACED BY ANOTHER CONTRACT

A specific contract (e.g. leasing contract) is terminated or expires (fixed-term contract) and is replaced by a new contract (e.g. subsequent leasing contract).


#### CONTRACT IS RELATED TO ANOTHER CONTRACT

A specific contract (e.g. service contract) is concluded, but in its context another contract is also legally valid (e.g. confidentiality agreement).

#### CONTRACT IS SUBORDINATE TO ANOTHER CONTRACT

A specific contract acts as a parenthesis or master agreement (e.g. mobile phone framework agreement) and defines basic clauses uniquely and superordinately. Corresponding subcontracts refer to this master agreement and define specific details (e.g. individual mobile phone contract).

It is possible to assign one or more relationships to each contract that is managed with Shareflex Contract. The relationship is always and automatically established in a bi-directional way.



#### OUTLOOK INTEGRATION


Shareflex Contract integrates seamlessly with Outlook via the user-friendly "Shareflex for Outlook" Sidebar.

Contract files and their contents can be searched and viewed directly in Outlook. Emails and their attachments, as well as documents from the file server, can be assigned to the relevant contract file by simply dragging and dropping them from Outlook.

It is also possible to email contract documents directly from Shareflex Outlook, allowing users to keep up to date. In this way, users of the contract management system always remain in their familiar working environment.

#### INTEGRATION WITH MICROSOFT TEAMS

Integration with Microsoft Teams is very easy because Shareflex Contract is based directly on Microsoft SharePoint. Contract and task lists, contract files and individual documents can be used as an application within a team or in a channel. It is also possible to include documents from Teams in a contract file and provide seamless access to them.

In addition, it is possible to make Shareflex Contract available as a standalone application in Microsoft Teams. This means that contracts and the entire contract management process can be accessed in a quick and easy way directly from within the Teams client.

## **AUTOMATIC GENERATION OF CONTRACT DOCUMENTS**

Shareflex Contract offers the possibility to automatically create documents from templates via an additional module. The content to be created can be imported directly from contract file metadata, stored text modules or data from third party systems. Interfaces to ERP systems such as SAP or Microsoft Dynamics are provided, as well as the ability to connect to any external database.


In addition, it is possible to scan contract documents and assign them directly to a contract file. Exactly as your business processes demand.

## WORKFLOW


Shareflex Contract allows both ad-hoc and rule-based workflows to be mapped in the standard, for example for technically demanding release and approval processes. These workflows can be adapted to new technical requirements at any time. A graphical workflow designer is also available for this purpose.

The look and feel of the workflow screens is identical to that used to manage contracts. So no further training will be needed to handle the workflow. Of course, workflows created with Shareflex can also be combined with workflows from Microsoft Power Automate.

#### REPORTING



#### **DIGITAL SIGNATURE**

In Shareflex Contract, all of the leading signature solutions, such as DocuSign, Adobe Sign or Microsoft Sign, can be integrated directly into the contract management system. This allows you to automate and simplify all important workflows.


The signed contract document is automatically saved by Shareflex Contract as a new version of the original document, so you always have access to the complete version history.



#### AI-BASED CONTRACT MANAGEMENT

With the Shareflex AI Studio, Shareflex Contract offers a powerful platform for the seamless integration of AI processes. This enables complex contract analysis to be carried out efficiently by automatically analysing contract documents and extracting relevant metadata. This greatly simplifies the creation and management of contract files. In addition, AI functionality allows documents to be summarised and translated into different languages.

A key benefit is the ability to manage the AI processes using the Shareflex AI Studio and to customise them using natural language. This ensures intuitive and flexible use without the need for extensive technical knowledge.
