Early Start

Phase 1

Phase 2

Once your business case is established, Project Hosts will move forward with completing your deployment, writing your SSP and collecting the evidence, documentation and diagrams to prepare you for your 3PAO Audit. This provides agencies and mission partners with an opportunity to access compliance and risk.

Phase 3

Project Hosts takes the lead, as an extension of your team, by engaging with the assessor on your behalf to represent you during the 3PAO audit. We provide all the services and coordination to implement and fully manage compliance, ensuring the CSP Software-as-a-Service (SaaS) solution passes required security audits and obtains a certification (or authorization) of compliance.

Continuous Monitoring

As a Managed Security Service Provider, our teams take responsibility for maintaining compliance and meeting the requirements set forth by the FedRAMP board and DISA.
