




QDS Solution Lifecycle






QDS Security Portfolio A360 Degree Approach

Base Solution

Deployment of the solution will be on the customers Azure tenant, which includes the WEB API and Web Interface. The Web Interface will be customized according to the company branding and theme.

Scope

The scope of the Web API will be:

- An API that can be consumed by another application to initiate the OCR process.
- The API will apply OCR and will return the extracted values in JSON format to the caller application.

The scope of the web interface will be:

- A landing page where the user will be able to search for the uploaded documents.
- A page to search within the document.

- Have your own Azure account.
- Make sure you can create Azure resources in your subscription (including paid resources).
