1. INTRODUCTION

During the workshop, issues related to data strategy will be discussed.

Good digital workplaces can improve the flexibility of employees. However, getting the most out of employees requires a new IT mindset. Transforming the employee experience results in a positive effect on employee satisfaction and productivity.

There is a large data component in both the new and the existing workplace. Proper and thorough handling of the usually privacy-sensitive information that employees handle on a daily basis is of great importance.
