Fighting the Fakes

Falsified medicines are a **serious and escalating problem** within the global pharmaceutical supply chain. Counterfeit drugs endanger patients by providing unsafe or ineffective treatments, undermining public trust in healthcare systems, and threatening the integrity of the supply chain. These counterfeit products can bypass traditional checks, posing **a significant risk to patient safety**.

What is the Falsified Medicines Directive (FMD)?

The **Falsified Medicines Directive (FMD)** was implemented to prevent falsified drugs in Europe's supply chain. It requires manufacturers to add unique barcodes and tamper-evident seals as safety features on each medicinal pack, ensuring patients receive authentic medications.

The FMD requires all EU countries to implement a **National Medicines Verification System (NMVS)** connected to the **European Medicines Verification Organisation's (EMVO)** central Hub.





What is SafeNationVS



SafeNationVS is Solidsoft Reply's **National Blueprint System (NBS)**. SafeNationVS is our pharmaceutical solution designed to help countries comply with the EU **Falsified Medicines Directive (FMD)**.

Based on our Microsoft global award-winning national medicine verification system, already used by over 20 countries, Solidsoft Reply offers a ready-to-go and customisable solution for LMICs. The system works by providing a national platform where pharmaceutical products are registered, authenticated and decommissioned before they reach consumers.

It enables **wholesalers and pharmacists** to verify the authenticity of medications by scanning unique identifiers on packaging and to meet the regulatory requirements of the FMD.

Solidsoft Reply is one of two certified companies in Europe qualified to provide the FMD National Blueprint System, and it is **the first supplier** to deliver a blueprint system.

SafeNationVS is fully compatible with the European Hub and markets across Europe. It supports all major European languages and runs on the same public cloud platform used to host the European Hub and other Solidsoft Reply national systems.

Fighting the fakes with SafeNationVS

The national system allows pharmacists and wholesalers to meet their legal obligations by verifying and decommissioning serialised medicine packs. It supports **single and 'bulk-of-pack' verification** and provides responses and notifications, including potential falsification alerts. The functionality is readily available through **a simple and modern programmatic interface**.

The system provides **extensive reporting for NMVOs and NCAs**, accessible through a secure portal. It supports the onboarding and management of pharmacists and wholesalers across the market. It integrates fully with the European Hub, including alerting for manufacturers and inter-market transactions.

NMVOs can integrate alert management tools or CRM systems with the National System through their choice of REST or AMQP interfaces.



Repository

The unique identifiers (UIs) and the associated data and events for each medicine pack or unit are stored and verified.



Robust Portal

The Administration portal allows NMVOs to graphically monitor the transaction volumes of pharmacy and wholesaler clients.



Compliance

Adheres to the Falsified Medicines Directive (FMD) and follows best practice. The system uses a GAMP®5 aligned quality management system to also ensure compliance.


