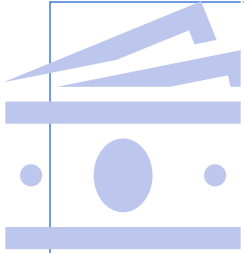

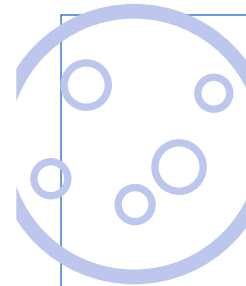

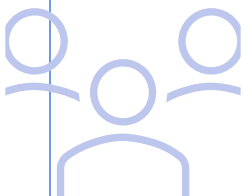

SCORE offers a user-friendly interface that requires no installation or technical knowledge, making it accessible to all organizations at all levels.



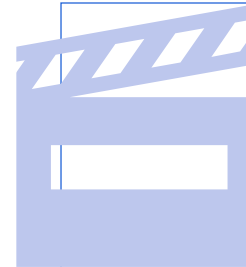

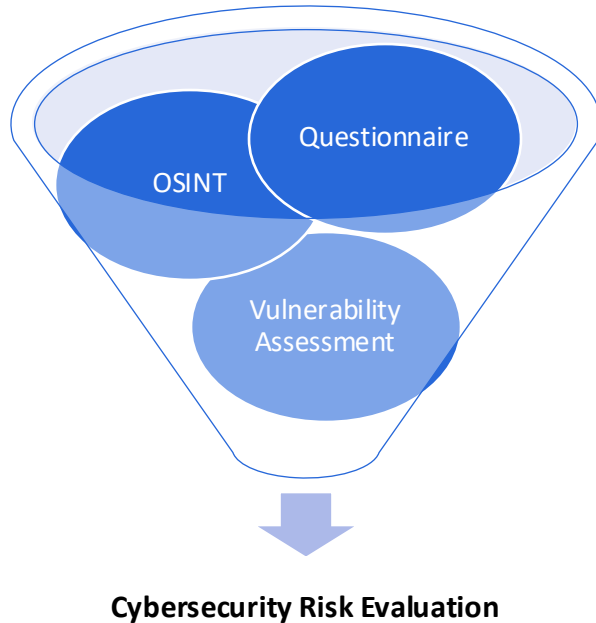
SCORE supports multiple users within an organization and operates on a multi-tenant architecture, allowing partners to use the platform efficiently.

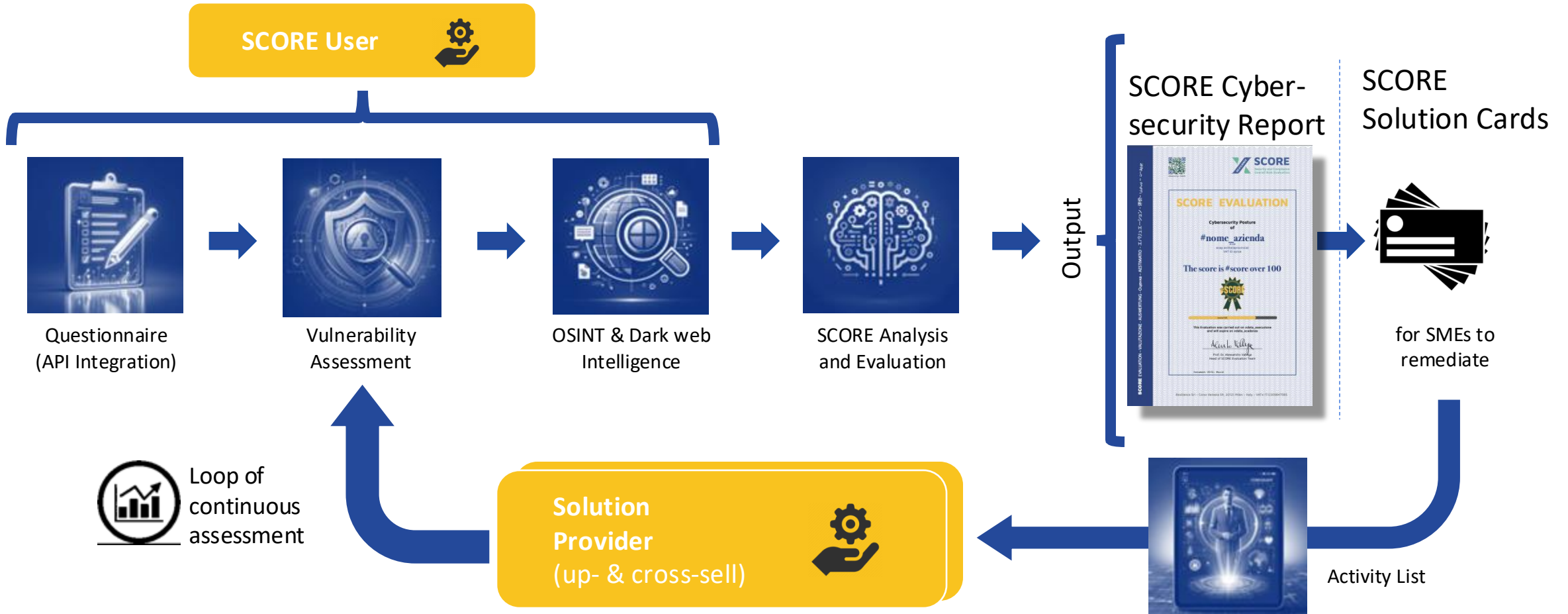

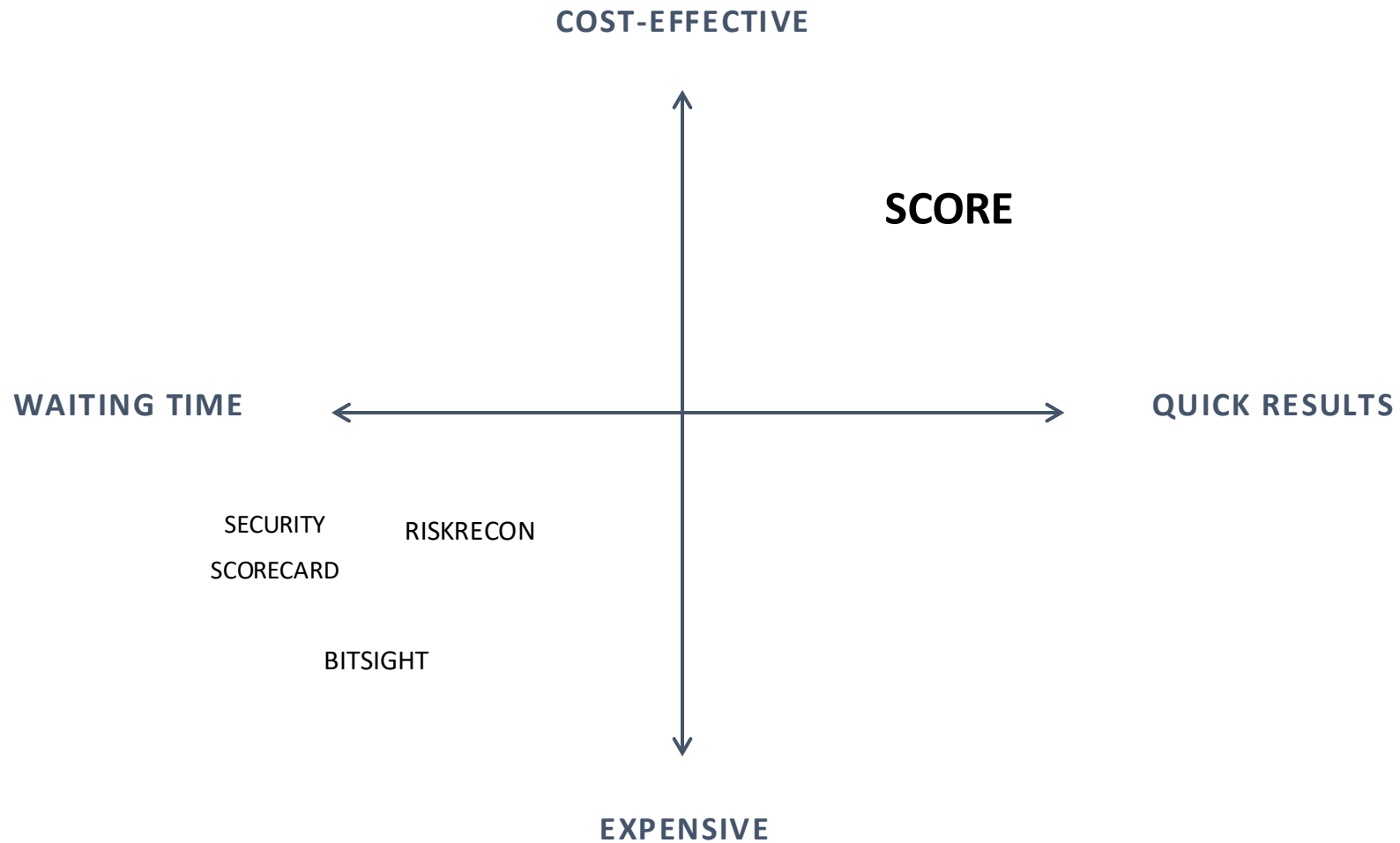
