# About the engagement

We will confirm the focus of the of engagement with you on day one.

We can assess the security configuration of Microsoft Office 365, Microsoft Azure laaS and PaaS and Dynamics 365 together or we can review them individually if you have particular concerns.

In order to run the assessment successfully risual would require the following prerequisites:-

- An active and licenced Microsoft Office 365
   Business or Enterprise tenant
- A Microsoft Azure tenant with live subscriptions enabled
- An active and licenced Dynamics 365 tenant
- An account assigned against at least one of the following Microsoft 365, Azure and Dynamics roles.
  - Global administrator
  - Security administrator
- Access to Microsoft Teams or video conferencing solution to allow for the interviews to take place.

Day 1 – On day 1, our Security Experts will work with you to truly understand your current challenges, existing solutions, and wider technology ecosystem. We will invoke the Microsoft Secure Score and Azure Security Center services using our custom develop scripts where possible. Our expert will interview your organisations security stakeholders to ensure we understand the current and future requirements.

Day 2 – On day 2, the risual team will review outputs from the tools and scripts to ensure the required information has been captured and reported on. If required further interviews will also ensure we have gathered all the information needed to create our recommendations for your security assessment.


