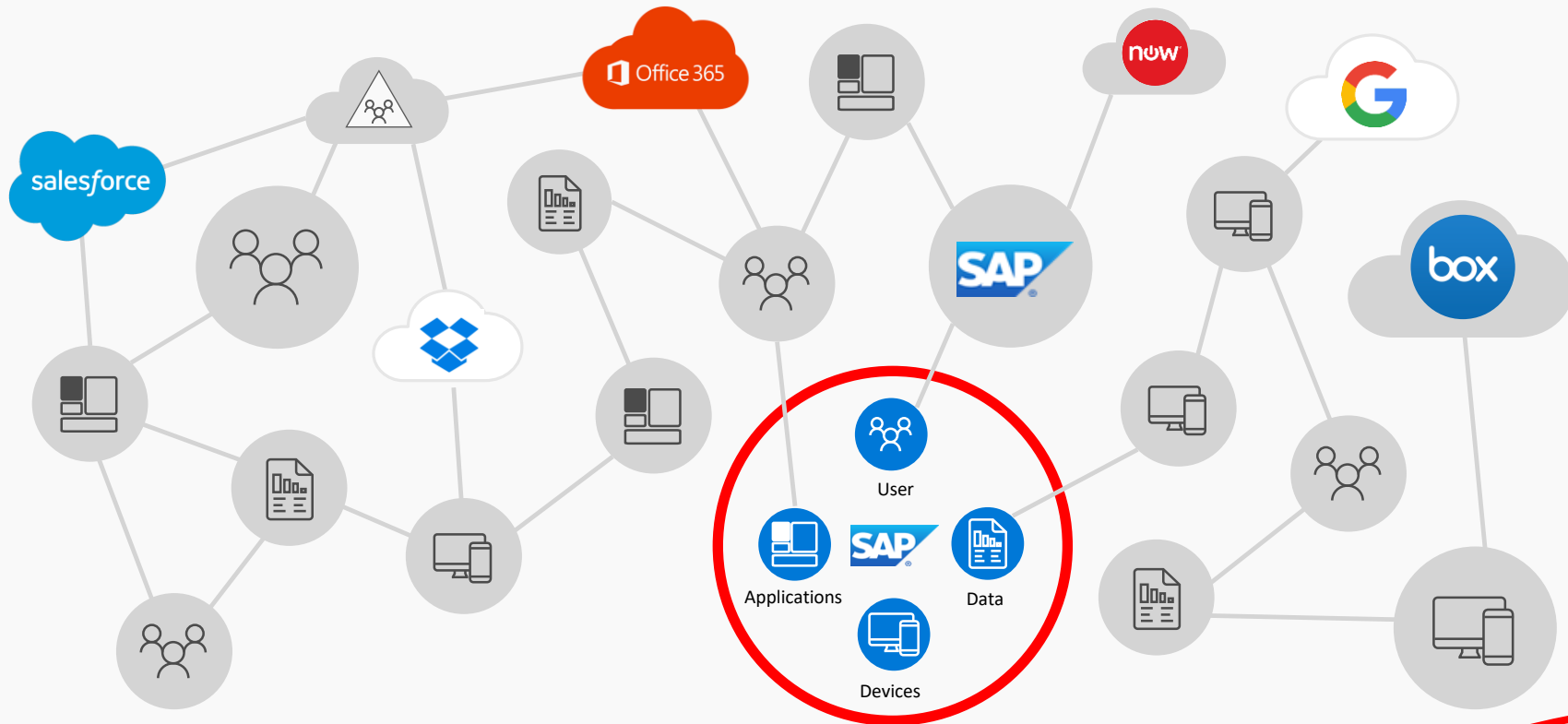

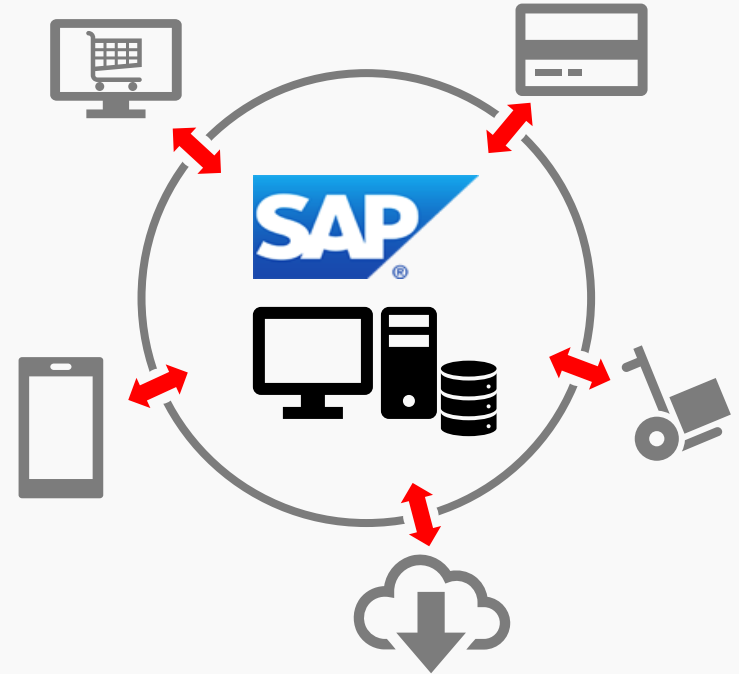

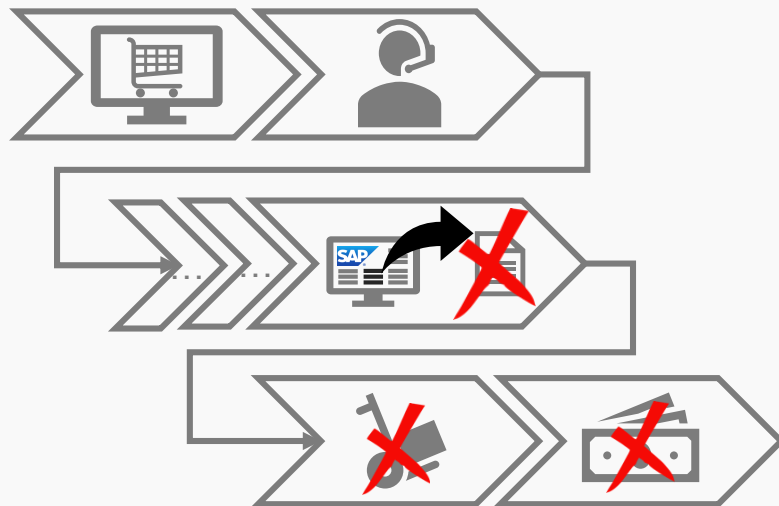

SAP users can export, print or email all data, which they are allowed to access.



But fundamental blocking of SAP data exports impedes most business processes.

SAP user authorization either allows all data exports or blocks them all for a user.

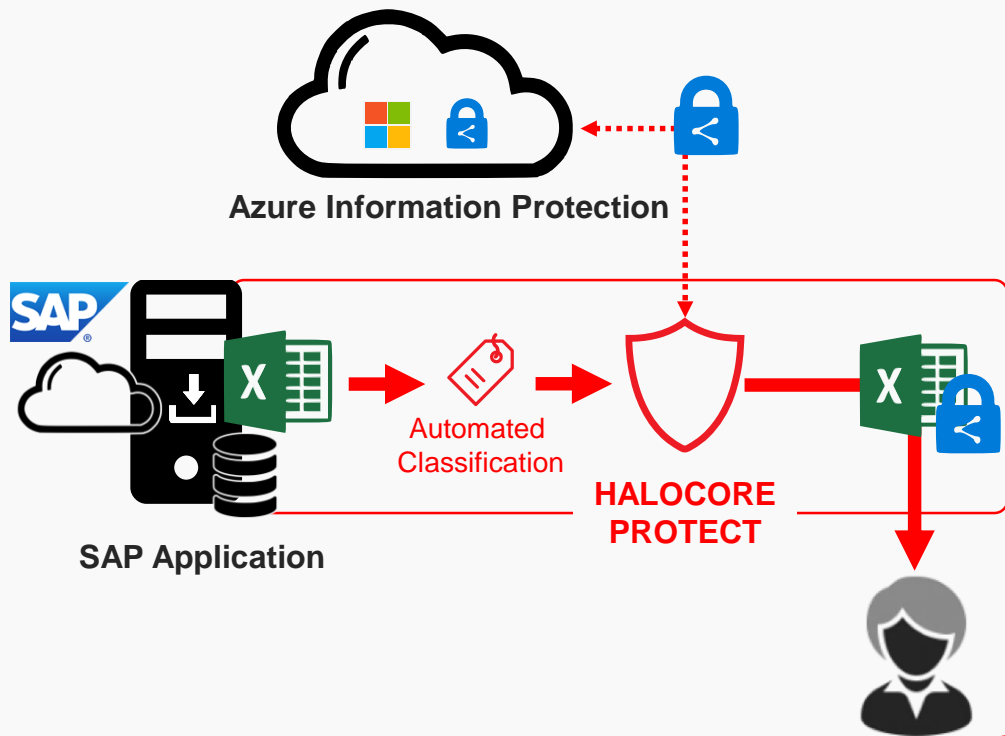

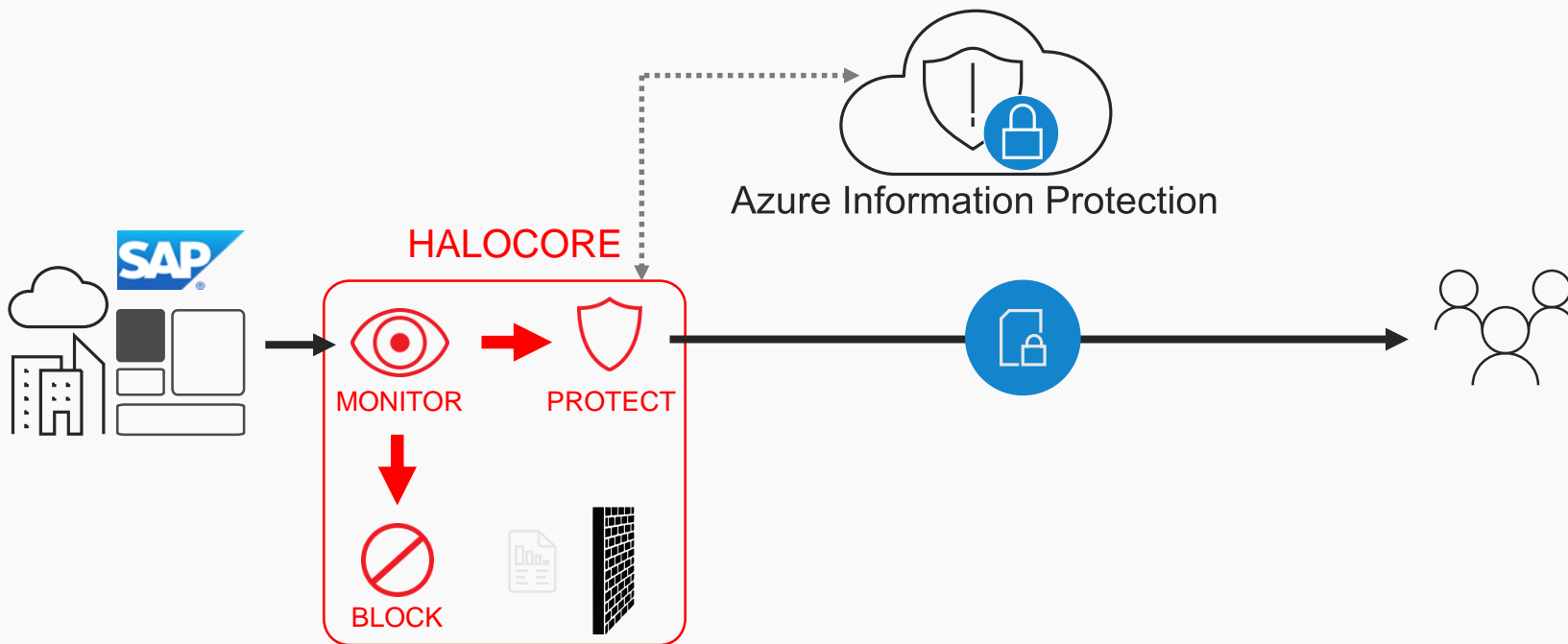

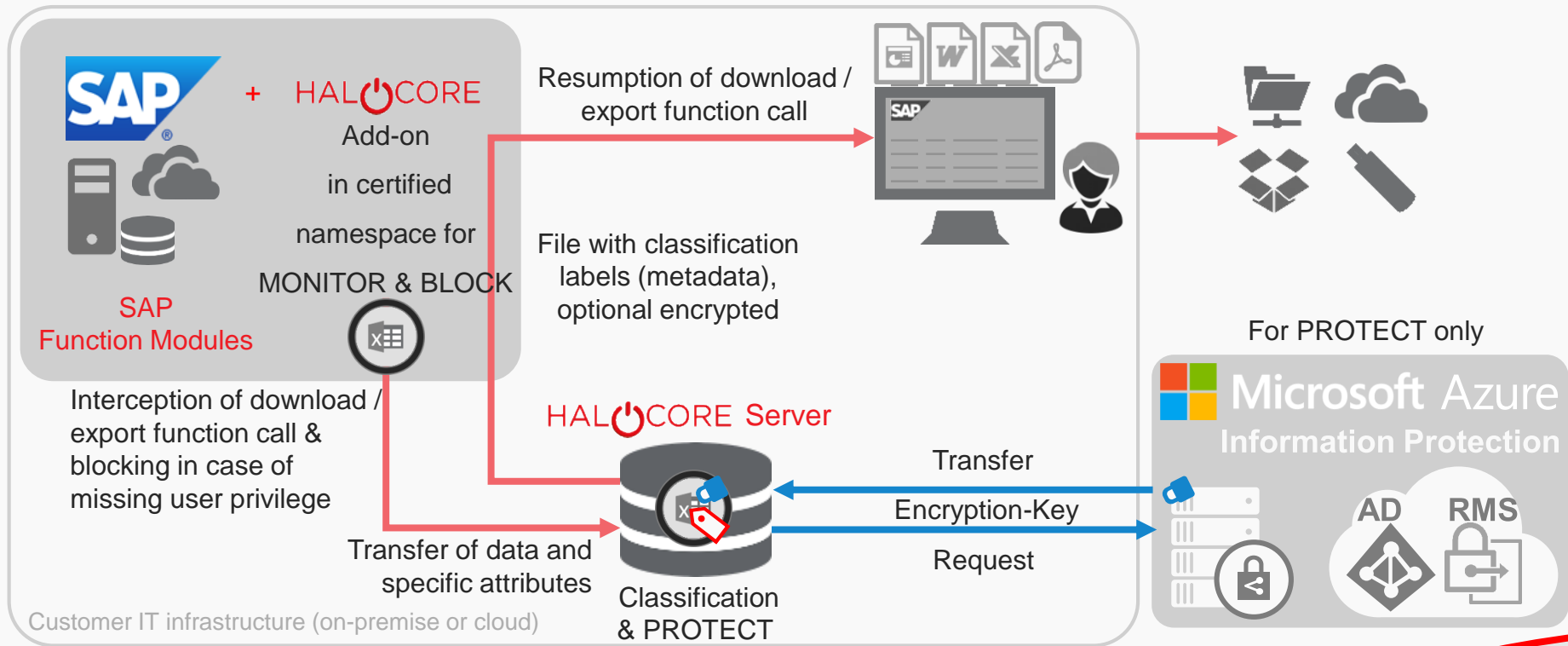
Integration in SIEM Solutions

- The HALOCORE audit log can be forwarded automatically to all kind of SIEM solutions, like SAP ETD, HP ArcSight, IBM Security Qradar, Splunk, etc.
- Supported log formats:
 - Common Event Format (CEF)
e.g. Syslog push to SAP ETD
([SAP HANA Smart Data Streaming \(SAP SDS\) Mapping](#))
 - Log Event Extended Format (LEEF)
 - JavaScript Object Notation (JSON)

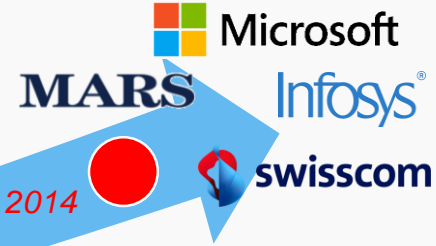
