#### Choose Any Combination of Mobile Archiving Methods for BYOD and Enterprise Phones

- Employee installs TeleMessage app on their device
- A secondary enterprise number is provided to the employee
- Messages and calls sent/received over the enterprise number arrive at the App
- A lightweight App is installed on the employee's Android device
- A copy of all mobile SMS / MMS and call recordings is sent from mobile phone to the archive server
- Works in the background without any user intervention
- WhatsApp messages are uploaded from the phone for archiving
- Archive WhatsApp text, chats, images, files and deleted messages
- Works from WhatsApp on your Mobile App and from the Web
- Identical to WhatsApp

Archiver

- Messages and calls are archived by the mobile operator at the network level, a copy is sent to the archive server
  - Can work for legacy phones. Enterprise only, no BYOD
- No App necessary

#### Enterprise Number Archiver



- A secondary enterprise number is provided to the employee
- TeleMessage app installed on employee mobile phone

### Android Archiver



- A lightweight app archives all messages and calls on the smartphone
- Use the native chat and phone dialer
- Capture all native Android text and call on the phone

### Network Archiver



- Mobile messages and calls captured by the mobile carrier's network
- A copy is sent to the TeleMessage archive server; No app required
- Direct carrier capture of mobile communication for archiving

#### WhatsApp Archiver



- Works in the background without any user intervention
- WhatsApp messages are uploaded to the TeleMessage server for archiving
- WhatsApp messages are uploaded to the TeleMessage server for archiving

- MiFID II: "...requires recording of telephone conversations, SMS, chat and mobile device applications..."
- SEC Regs: "...must archive text/SMS messaging and apps..."
