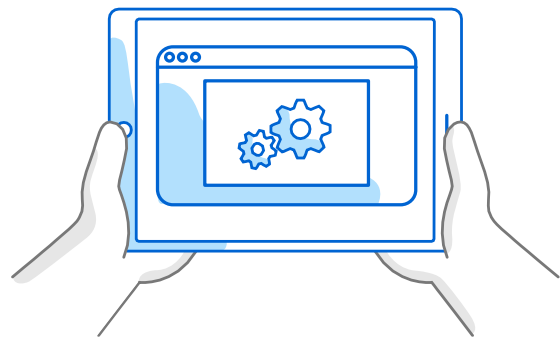
The Process



- An independent assessment by a software audit advisory expert without any software publisher bias or oversight
- Deployment of industry leading tool to collect baseline data & performance measurements for the duration of the engagement. This information is used to assess licensing requirements and right size the environment
- Review any existing Microsoft Enterprise Agreement and other licensing agreements seeking to reduce costs through better use of current licensing methods
- Provide a detailed review of how recent changes to Microsoft licensing usage rights can impact existing and future workloads
- Determine the licensing position for both your existing Azure tenancy & on-premises environments



The Value



- Avoid the license compliance traps that recent changes to Microsoft licensing rules can cause
- Obtain a detailed roadmap for how you can and cannot use existing volume licenses in Azure
- Understand the pros & cons and costs of using existing Microsoft volume licenses versus Azure licenses included with the platform
- Obtain Microsoft Windows and SQL Server licensing cost optimisation recommendations
- Use information to prepare for a Microsoft Enterprise Agreement true up, renewal or just get an assessment of your current Microsoft licensing position
- Azure instance sizing, pricing and application dependency details for moving on-premises workloads to Azure

TCO/OLA – Process Outline

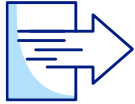
Telstra Purple in collaboration with Microsoft will partner with you on the following process outlined below to provide a Total Cost of Ownership, Optimisation and Licensing Assessment.

Let's get it done...



Scope of Work (SoW)

- Qualification process will be undertaken by a Telstra Purple Technical Consultant in partnership with your technical team to ensure the correct Discovery Tool is selected to perform the assessment
- A SoW is signed off by both the Client and Telstra Purple agreeing on the outputs delivered as part of the assessment



Phase 1 - Kick-off

- A Kick-off meeting between the Client and Telstra Purple to initiate the assessment is scheduled and attended by all interested parties to discuss the SoW, timelines and in-scope deliverables



Phase 2 - Data Collection

- A session between the Client and Telstra Purple technical teams to initiate the Discovery Tool installation & configuration
- Allow 4 – 6 weeks for the Discovery Tool to collect meaningful data
- A session between the Client and Telstra Purple technical teams to confirm current Microsoft licensing details



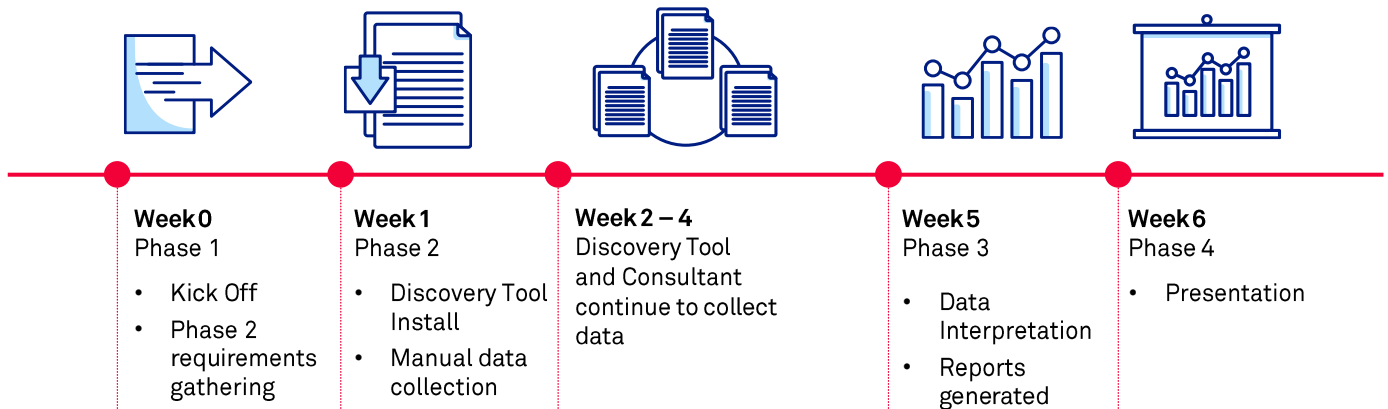
Phases 3 & 4 – Reporting

- Allow up to 2 weeks for the generation of the TCO/OLA report
- A session between the Client and Telstra Purple teams to present the TCO Assessment

TCO/OLA Timeline

The anticipated duration of the assessment is 6 – 8 weeks (depending on the chosen data collection period of 4-6 weeks)
