Always knowing where you stand and what you're doing next is more than good compliance, it's good business.

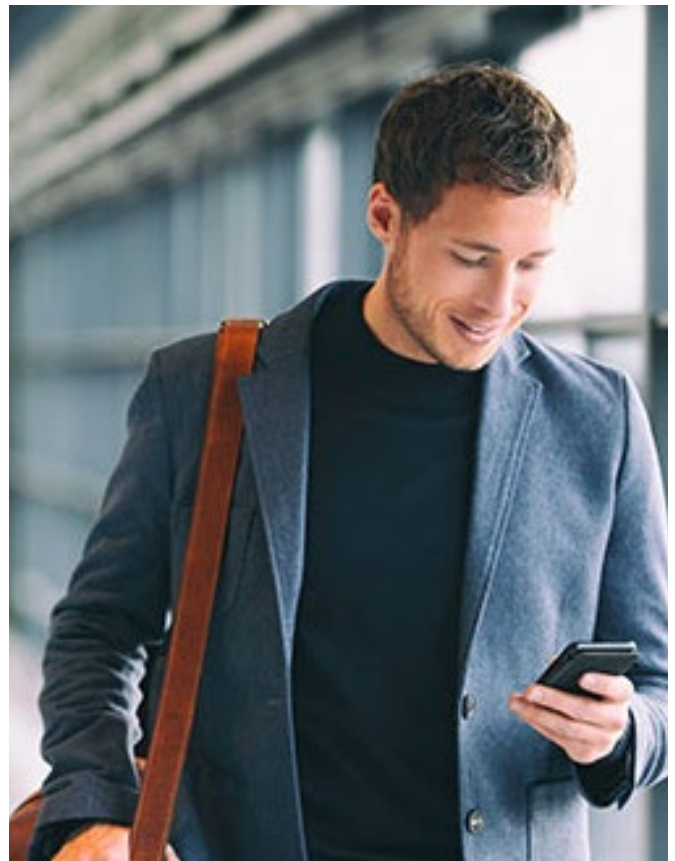
Data loss, through inadequate systems, can have a devastating impact in terms of lack of customer confidence, your information in the hands of competitors, and significant fines.

- Keeping compliance costs under control.

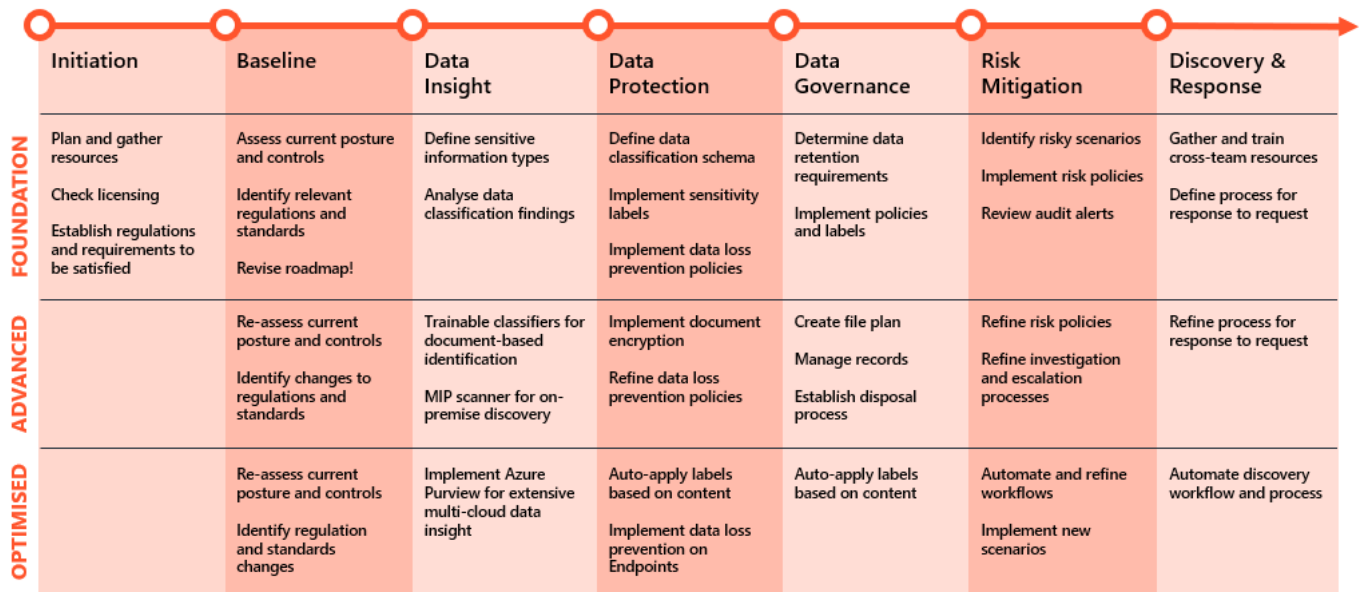


The seven steps to compliance success
