While governance is often focused on security, we will also work with you on an internal communication plan, and new-maker recruitment and training process to ensure innovative users have a way to request access to and participate in the programme – using the 'Nurture' templates available from Microsoft.

Finally, we will ensure that appropriate administrators and managers have access to reporting, so that platform performance, adoption and user behaviours can be quickly and easily reviewed as part of ongoing governance.
