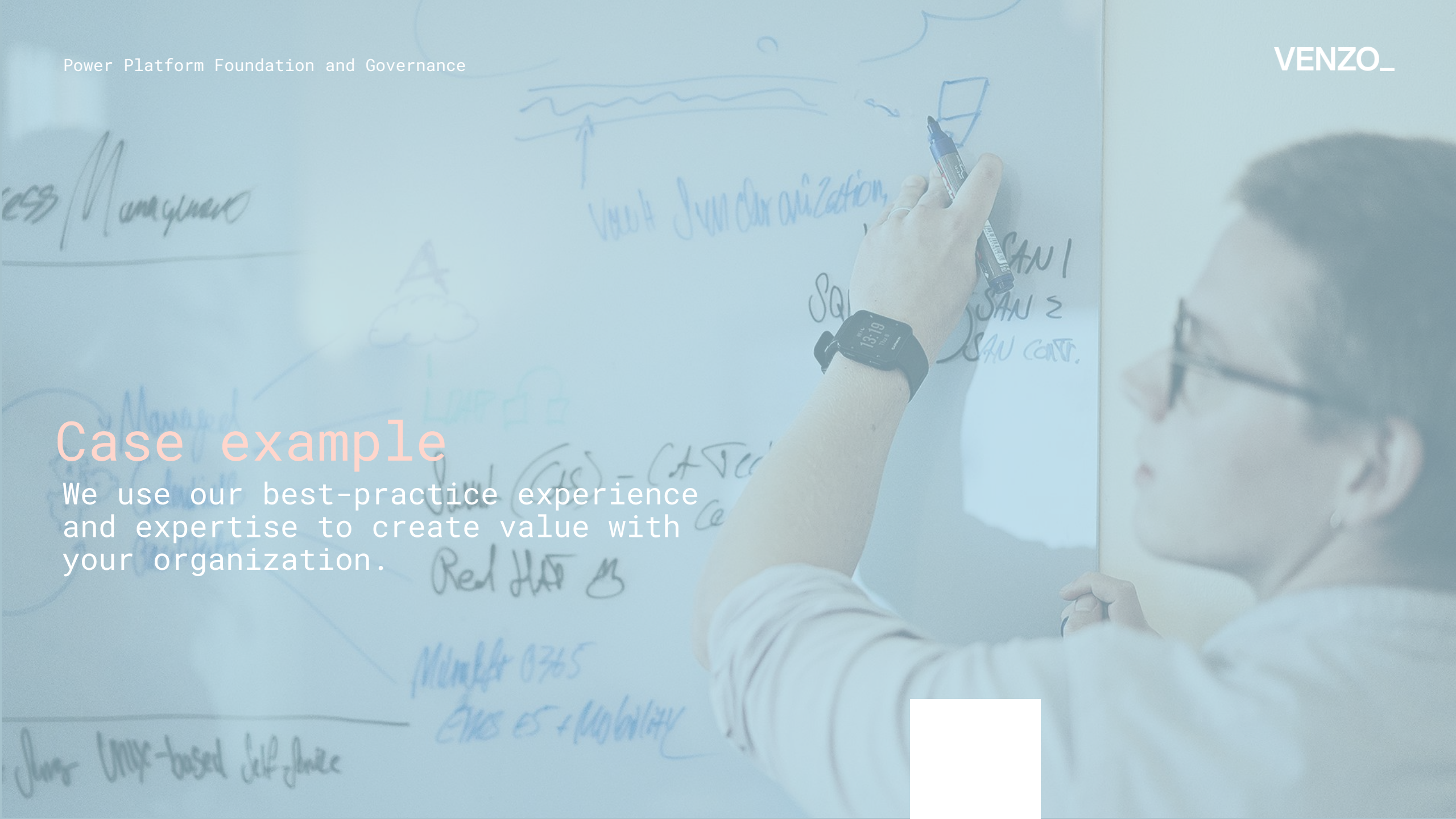

## Ensure efficient organizational governance structure for the Power Platform
