DevOps Assessment – One Day Workshop

If you are in a highly regulated sector – like public, financial, medical, pharmaceutical, food, or defense – you have to comply to many regulations. This often is a hurdle when adopting DevOps tooling and methods.

In this one-day workshop we assess and understand your capabilities, demands, and regulations and develop a plan to enroll DevOps in your organization.

1 Goal

The goal of this workshop is to define a strategy for rolling out tooling and methodology. The options for tooling include the hosting options, pricing, sizing, and target platforms for deployment:

- GitHub Enterprise Server / Cloud
- Azure DevOps
- Jira, Confluence, Trello
- Code quality tooling
- Build environments
- Hosting Platforms

We develop a suitable plan for you in terms of data residency, manageability, scalability, and cost efficiency.

The one-day (2x4 hours) workshop will be interactive and with two DevOps experts from our side.

2.1 Context assessment

In the first part of the workshop we gather information about your situation:

- ✓ How many developers or partners are developing software?
- ✓ What kind of software are you developing/running?
- ✓ What technologies, platforms and processes are in place?
- ✓ How is your organisational structure?
- ✓ What are your constraints?

It is important to have representatives from you IT department, development, and product management. If you develop with partners, it would be also requested to have a representative that knows the processes and technologies that are in place.

2.2 DevOps Vision

In the second part we define the vision of what you want to achieve. What is the desired outcome and what is out of scope.

2.3 DevOps Strategy

After lunch break we define a winning strategy how to achieve your vision. This includes the right tooling and hosting options, the best methods and processes, and the best way to get there (roll-out, training, organizational changes etc.).

2.4 Next steps

As a last step we define the next steps to embark on the journey.

A clear vision and roadmap for implementing DevOps in your organization.
