

## How standard role definition & licensing works in Microsoft Dynamics 365

Security configuration in Dynamics 365 for Finance and Operations is based on "Entry points" which are the smallest access points in the system.

In other words we can say that every: table, button, function etc. contain entry point which defines access to particular element.

Entry points are group with Privileges and then privileges are grouped in Duties. Then Security Roles inside Dynamics are combination of Duties and Privileges to define end access for the user. Of course user can use combination of roles too.

**Entry points and actions performed on those entry** points define also license type requied for this element and activity on it.
